#### Kennedy-King Park Softball Usage Agreement

White Township will provide Indiana Area School District (IASD) girls softball team access of the multipurpose field at Kennedy King Park for the 2019 spring softball season and thereafter under the following conditions:

- 1. IASD will take priority over all other groups for both practices and games.
- 2. IASD is completely responsible for infield preparation and mowing for all practices and games. White Township does not have the manpower to prepare or maintain the field to the level required for competitive play during the season.
- 3. White Township will loan a field groomer to the IASD Maintenance Department. IASD will be responsible for any and all costs due to damage or mechanical failures of the groomer. Cooperation and sharing of equipment is expected by both parties in the case of a mechanical failure.
- 4. White Township will charge \$500.00 for use of the field and the Field Groomer per season or until IASD procures their own equipment.
- 5. The site does not have running water, restrooms, or electricity. IASD will be completely responsible for any and all amenities needed for all practices and games. Should portable toilets be placed on site they must be in a location that is ADA accessible. White Township recommends placing them on the paved surface by the playground.
- 6. IASD will purchase their own infield conditioning materials. Only Calcined clay and diatomaceous earth products are permitted. Organic materials such as saw dust or cat litter are not permitted.
- 7. Should IASD require Infield Mix, White Township will sell IASD material at our cost. IASD is not permitted to use non approved infield mix.

- 8. IASD agrees to contribute up to \$5,000 for the completion of the fencing including the backstop wings and the outfield. Once installed White Township will be responsible for maintaining the fencing and all costs associated unless IASD personnel or staff is directly responsible for the damage. At that time White Township will invoice IASD for the cost to repair the damage.
- 9. IASD must gain permission from White Township to hang signage and/or any alteration or addition to the site.
- 10. This agreement is open ended, either party can mutually agree on amendments to this agreement at any time.

Note: The Kennedy-King Field was developed with a substantial monetary commitment approved by the Supervisors. White Township has no plans or budget for public restrooms, electrical access, dug outs, outfield fencing or additional parking at this time. White Township will entertain proposals for future development but will likely require financial support to cover the cost of the development.
