Parents and/or guardians agree to pay tuition, fees, and other charges in a prompt and timely manner. Parents and/or guardians understand that non-payment or late payment of tuition, fees and other charges will result in the following consequences: (1) Late Fees, (2) Exclusion from final exams and/or dismissal of the student from school, as well as (3) Graduation penalties. In the event of non-payment, I (We) agree to pay all penalty costs and all costs of collection including reasonable attorney fees incurred by the school.

This tuition contract represents the commitment of the undersigned legal adult(s) to pay the entire 2019-2020 tuition amount or the adjusted tuition amount due to financial tuition reduction, even if the above named student leaves the school during the year or is expelled during the year. After August 1, no portion of paid tuition or tuition due will be refunded or cancelled unless a Tuition Assurance Policy has been purchased.
