Winter Activities Release of Liability and Indemnity Agreement**

**READ CAREFULLY BEFORE SIGNING – THIS LIMITS BOREAL/SODA SPRINGS' LIABILITY**

1. I, \_\_\_\_\_, or my child (collectively referred to as "I", "my", or "me") have voluntarily applied to participate in winter sports and other recreational activities at Boreal Mountain Resort, Soda Springs Mountain Resort and/or Woodward Tahoe ("Boreal"), including but not limited to, skiing, snowboarding, snowtubing, sledding, all other winter sports or related activities, and all activities at Boreal Playland, Soda Springs Planet Kids, and Mini-Snowmobiles (collectively referred to as "the Activities"). I understand that my participation in the Activities can be **DANGEROUS** and pose risk of **INJURY** and **DEATH**.

2. I understand that the Activities include numerous risks including but not limited to, loss of balance, control, falling, sliding, collisions with other ski area patrons, participants and spectators in the activities, and all natural and man-made objects, padded or not, (including, but not limited to, trees, rocks, fences, lift towers, race gates, snow making or snow grooming equipment, snowmobiles, snowcats and other vehicles). The risks also include variations in terrain, variations in weather, surface and subsurface snow conditions, icy or firm snow, bare spots, bumps, ruts, moguls, ice, stumps, forest growth and debris, erosion control devices, rocks, cliffs, steep terrain, avalanches and avalanche debris and other hazards, traveling in the mountains and beyond the ski area boundary, risks associated with mountain transportation, loading, riding and unloading ski lifts, use of terrain parks (jumps, rails, boxes, half pipes, and other park features), slope style, skier/boarder-cross, use of Wrecktangle ®, performing maneuvers (inverted or otherwise), use of lodges and parking lots, and participating in lessons, races, and special events (collectively, "Use of the Facilities").

3. I understand that if I enter a terrain park, I must inspect the elements and terrain before I ski or ride over them to evaluate the risks and degree of difficulty before participating. I understand that throughout the day snow conditions and terrain features will change. I am solely responsible for knowing and understanding my ability to encounter all terrain features.

4. Despite the risks involved in the Activities and as consideration for being allowed to participate, I **AGREE TO EXPRESSLY ASSUME ANY AND ALL RISK OF INJURY AND DEATH** that might be associated with or arise out of my participation in the Activities or use of the Facilities.

5. In consideration for being permitted to participate in the Activities and Use of the Facilities, **I AGREE TO RELEASE FROM ANY LEGAL LIABILITY AND AGREE NEVER TO SUE** Boreal Ridge Corporation, Boreal Mountain Resort, Woodward Tahoe, Soda Springs Mountain Resort, Powdr Corp., Powdr-Woodward PA LLC, Auburn Ski Club, or any of their parent companies, subsidiaries, owners, investors, employees, agents, landowners, or The United States of America Department of Agriculture, Forest Service (collectively, "Boreal") for injury or death resulting from my participation in the activities or use of the facilities, regardless of the cause, including the alleged **NEGLIGENCE** of Boreal.

**6. I UNDERSTAND THIS IS A RELEASE OF LIABILITY THAT IS VALID FOREVER**, and will apply whenever I participate in the Activities or Use of the Facilities at Boreal. I understand that this **RELEASE OF LIABILITY** will prevent me, my child, or my heirs from filing suit or making any claim for damages in the event of injury or death from my participation in the Activities or Use of the Facilities. Additionally, in the event I file or my child or any legal representative files a claim or a lawsuit arising out of my participation in the activities or the use of the facilities at Boreal, **I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS** Boreal for any damages, attorney's fees, or costs arising out of such a claim or a lawsuit. With a full understanding of this agreement, I nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon me, my child, my heirs, assigns and legal representatives.

7. Ski areas routinely take photographs and videos for commercial purposes and patrons may be readily identifiable in these images. I hereby authorize the use and reproduction of my image and/or likeness by Boreal and its authorized representatives, without compensation or restriction. Photographers executing this agreement understand that images they take at Boreal may be used by Boreal, at any time.

8. I understand and agree that this agreement is severable and that if any clause is found to be invalid, the balance of the contract will remain in effect and will be valid and enforceable. I agree that any action will be brought in the California Superior Court, County of Nevada. Any disputes will be subject to and determined under the laws of the State of California.

9. By executing this Agreement, I declare under penalty of perjury that I am doing so only for myself and/or my child or participants for whom I am authorized. If I execute this Release of Liability and Indemnity Agreement on behalf of another person, I understand and agree that I am acting as the agent for that person and my signature expressly confirms that I have permission to sign on the other person's behalf, and this agreement shall be binding upon that person if the other person brings a claim or lawsuit against Boreal. I agree to defend, indemnify and hold harmless Boreal as fully set forth above. If I sign without the express permission of any other person, I understand and agree that I am committing fraud against Boreal.

**MEDICAL RELEASE AND PERMISSION TO TREAT A MINOR**

In the event of a medical emergency relative to my child, I hereby give consent to Boreal to provide any and all emergency first aid treatment and/or refer treatment to emergency personnel, physicians, dentists, or other medical care providers to my child. This care may be given under whatever conditions are deemed necessary at the time to preserve the life, limb or well-being of my child. The undersigned agrees to pay all costs associated with such treatment provided by said medical providers and related transportation for the child, and agrees to **INDEMNIFY** and **HOLD HARMLESS** Boreal for any cost incurred therein.

## BOREAL / SODA SPRINGS / WOODWARD SPORTS INSTRUCTION AND RENTAL EQUIPMENT AGREEMENT AND RELEASE OF LIABILITY

1. I, my child, and/or the user of this equipment (collectively, "I," "me," or "my") accept "as is" ALL equipment listed on this form (the "equipment"). I accept full responsibility for the care of the equipment while it is in my possession.
2. I understand that equipment rental is charged for the full time it is in my possession, even if equipment is unused for all or part of such period. Late returns for any reason, including inclement weather, will not be an exception to this provision. If I fail to return the equipment, I will reimburse Boreal for the equipment at full retail value. Rental equipment is nontransferable. If I transfer any equipment, I agree to indemnify Boreal for any damages related to the improper transfer, including but not limited to injury to the transferee while using the equipment.
3. I acknowledge that I fully understand the use and function of the equipment. I acknowledge that I have received full instruction on the use of the equipment, and that I understand the use and function of the equipment. I understand it is my responsibility to inspect the equipment, including but not limited to bindings, skis, snowboards, poles, boots, and helmet for anything out of the ordinary that may affect the equipment's function. I have made no misrepresentation to Boreal with regard to information related to the rental and/or use of the equipment. I understand that the equipment may only be used on the premises.
4. I understand that skiing, snowboarding, other winter sports activities, instruction in those activities, and use of the equipment (collectively, "Activities") can be dangerous and involve risks of injury or death. Despite the risks involved and in consideration for being allowed to rent the equipment and/or participate in the activities, **I AGREE TO EXPRESSLY ASSUME ALL RISKS OF INJURY OR DEATH** that may be associated with my use of the equipment, participation in the Activities, and use of the facilities at Boreal, Soda Springs, and Woodward, including but not limited to use of equipment, terrain parks and terrain features, chairlifts, mountain transportation, buildings and parking lots, participation in snow sports, instruction, racing, special events, and traveling beyond the ski area boundary (collectively, "Use of the Facilities").
5. To the fullest extent allowed by law, **I AGREE NEVER TO SUE AND TO RELEASE FROM LIABILITY** Boreal Ridge Corporation (dba Woodward Tahoe), Boreal Mountain Resort, Woodward Tahoe, Soda Springs, Powdr Corp., Powdr-Woodward PA LLC, Auburn Ski Club, the Department of Agriculture, United States Forest Service, and their respective owners, investors, members, managers, officers, directors, employees, agents, representatives, landowners, subsidiaries, and affiliated companies (collectively herein, "Boreal") for damages, injury, or death to me or my child arising from my or my child's or the user's participation in the Activities and/or Use of the Facilities, regardless of cause, including allegedly negligent instruction or any alleged **NEGLIGENCE** of Boreal.
6. I understand this **RELEASE OF LIABILITY IS VALID FOREVER** and that it is binding upon and will prevent me or any heirs from filing suit or making any claim for damages in the event of injury or death to me or my child. Additionally, in the event that I, any legal representative, or any other person acting on my behalf files a claim or a lawsuit arising out of my participation in the Activities or Use of the Facilities, **I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS** Boreal for any damages, attorney's fees or costs arising out of such a claim or a lawsuit. With a full understanding of this Agreement, I nevertheless enter into it freely and voluntarily.
7. **SEVERABILITY/VENUE/CHOICE OF LAW:** I understand this agreement is severable and if any clause is found invalid, the balance of the agreement will remain in effect, valid, and enforceable. I agree that any action related to this agreement must be brought the Nevada County Superior Court of California, and that all disputes related to this agreement will be determined under California law.
8. **HELMETS:** I understand that no helmet can protect the user from all foreseeable impacts or injury, and that the Activities and Use of the Facilities present situations that may surpass the limits of protection offered by helmets. However, I understand that for maximum protection, the helmet must fit snugly and the retention system must be fastened securely at all times. I agree that the helmet has been properly fitted and that I (or my child, if my child has been disclosed to Boreal as the person using the helmet) will be the only person using this helmet. **If the helmet experiences an impact, for my safety and the safety of future users, I agree to immediately inform rental shop personnel that the helmet experienced an impact.**
9. **SKI/SNOWBOARD BINDINGS/ EQUIPMENT:** I understand that the ski/boot/binding system is designed to reduce the risk or degree of injuries but will not release at all times or under all circumstances, nor is it possible to predict every situation in which it will release, and is no guarantee of the user's safety. I understand that any equipment other than skis are not designed to release as the result of forces generated during ordinary use, and are no guarantee of my or the user's safety. I verify that any snowboard provided for my use is equipped with a leash/retention device. I agree that it is my responsibility to use this device to prevent runaway equipment. I acknowledge that I may lose my lift ticket or pass and will be held financially liable for any damage to property or persons caused by loose equipment.
10. **REQUESTED SETTINGS/SERVICES:** I authorize Boreal to perform such work that is necessary to properly mount, test and/or repair the equipment. I have verified that the release setting numbers recorded on this form correspond with the numbers appearing on the visual indicator windows of the ski bindings. I acknowledge that there may be an increased risk of injury to me as a result of my own personal preferences for the binding settings.
11. **PARENTS/GUARDIANS OF MINORS IN SPORTS INSTRUCTION:** I agree to stay on the premises at all time while my child is in a lesson. I understand that Boreal REQUIRES all minors to wear a helmet during lessons, and that failure to agree to or comply with these requirements means that my child will not be allowed to participate in any lesson.
12. **MEDICAL RELEASE AND PERMISSION TO TREAT A MINOR:** In the event of a medical emergency to my child, I hereby give consent to Boreal to provide any emergency first aid treatment and/or refer treatment to emergency personnel, physicians, dentists or other medical care providers under whatever conditions are deemed necessary at the time to preserve the life, limb or well-being of my child. I agree to pay all costs associated with such treatment and related transportation for my child, and to INDEMNIFY and HOLD HARMLESS Boreal for the costs.
13. **CHAIRLIFTS:** I understand that my child may be riding lifts alone or with other children or adults while enrolled in lessons. Please advise a supervisor in advance if you do not want your child to ride a chairlift.
14. Prospective renters and lesson participants under the age of 18 years are required to have a parent, legal guardian, or authorized adult read and sign, verifying that the parent/legal guardian/authorized adult has read and understands this agreement and agrees to be bound by its terms. In executing this agreement, I declare under penalty of perjury under California law that I am doing so only for myself and/or on behalf of persons for whom I am the parent, legal guardian or authorized adult. In the event that I execute this Release on behalf of another person, I understand and agree that I am acting as the agent for that person and my signature expressly confirms authorization to act on their behalf; in the event that other person brings a claim against Boreal, I agree to defend, indemnify and hold harmless Boreal as fully set forth above.
