Re: Nutrition Services Bid November 2017 Award Recommendations

Accompanying this memorandum, you will find our recommendations for awards for the Nutrition Services bids for Food Products and Fresh Fruit & Produce for Spring 2017 (for the term January 1 – June 30, 2018) and for Paper & Cleaning Products Additions (as additions to existing contracts in effect through June 30, 2018 or issued as new agreements for January 1- June 30, 2018 in the case of winning bidders who do not have a purchase agreement in place).

The award recommendations are generally based on bid price rankings, with the low bidder deemed the winning bidder, and all other things considered equal. When an award does not strictly follow this low-price-wins criterion, we have provided an explanation for the alternative recommendation.

In the case of some items, a bidder's offered price was not ranked and thus not considered for award. This may be the result of any number of defects with the bid:

- A bidder offered an item other than was specified and failed to submit the alternative for pre-approval by Nutrition Services
- A bidder submitted an alternative for pre-approval but the sample did not meet requisite nutritional values or was deemed to be of insufficient quality
- A bidder failed to submit a sample as specifically requested in the item description, in the case of an item for which no particular brand was requested (generally listed as "distributor's choice").

This is not an exhaustive list of possible defects, but those listed are the most common. When a non-ranking affects an otherwise winning bid, the non-ranking is explained. When the non-ranking does not affect the recommendation, no explanation is provided as the rank omission is inconsequential to the award. In the interest of transparency, all offered bids are included in the ranking detail, whether ranked or not.

For a few items, no award is recommended. We have included a list of these as well as an explanation for the No Award recommendation. In the case of several items from the Fruit & Produce bid, the items not awarded due to receiving no bids for that item will be priced and purchased using price quotes from qualified vendors, on an ad hoc basis.

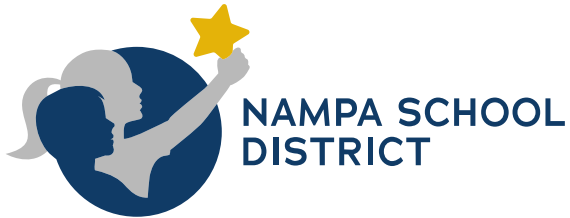

Nutrition Services
Bid Award Objection Procedures**

Any participating bidder may object to a bid award, pursuant to the requirements of Title 67, Chapter 28, Idaho Code.

A bidder who wishes to object a bid award must do so within seven (7) calendar days of the posting of the award. This objection should be submitted, in writing, to the District's coordinating party as listed in the publicly posted bid documents specifying bid items, procedures, and other requirements. The objection must set forth the express reason(s) for the objection and why the award has been made in error. Upon receipt of a proper objection, the governing party for the bid in question will stay its award decision and any procurement under the award until it has addressed the particular objection(s) submitted.

The governing party shall review its decision and will determine to (1) affirm the award, (2) modify the award, or (3) repeat the bid process, setting aside its award, and will set forth its reasons therefor. After completion of the review process, the District may proceed as it deems to be in the best interest of the District.

For the purposes of bid objections, the governing party shall be whatever person or group is duly empowered and qualified to make an award, under procurement laws and guidelines set forth by the State of Idaho for political subdivision purchasing and Nampa School District purchasing rules.
