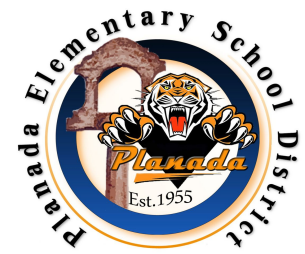

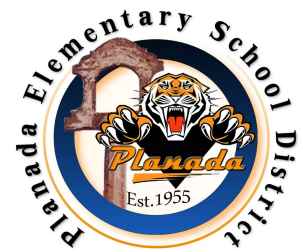

Vendor Booth Information and Rules

Thank you for your interest in our Fall Festival. We greatly appreciate participation from the community and hope this event will be a successful fun family based entertainment for our community. Gates open at 3:00pm for Booth set up. The event will run from 5:00pm to 7:00pm on **Sunday, October 28, 2018.**

To ensure that there are no conflicts between booths, no duplicate items will be allowed to be sold. CECMS Parent Booster Club will be selling all drinks/beverages. Due to our no duplicate booth policy, no other booths will be allowed to sell any drinks or beverages. This is to allow vendors the best opportunity to raise funds without having to compete with others selling the same items. Booths are approved on a first come, first serve basis. There is a \$10 donation fee per booth. Donation is due at the time your application is submitted.

All Booth operators are responsible for bringing their own items needed to maintain or operate their booths. This includes but is not limited to cash/change, chairs, tables, tents/shades, extension/electric cords, ice, coolers, signs, tape, scissors, markers, rope, hooks, paint or any other supplies that might be needed to operate your booth. Due to high interest of participation for this event CECMS will be unable to supply any of these items.

If you are planning on selling food items that must be cooked, please be advised that open flames will NOT be allowed for this event. Therefore, no grills or portable stove tops that have open flames will be allowed in the area. Please make the appropriate arrangements for any foods being sold.

The deadline to submit your application is **Thursday, October 25th, 2018.** This will allow for us to plan appropriately for booth set up and layout. Be sure to fill out the Booth application completely so that we may notify you of approval. Incomplete applications will NOT be accepted. Please allow at least 24 hours for a response.
