Please take note of the Non-Tithing Annual Tuition rate listed in the chart above. This rate will be applied for the 2020-2021 school year. Non-Tithing rate refers to families who are not registered at a Catholic church and do not actively donate/contribute \$100 during the 2019-2020 school year. Families will have the option of becoming active contributing parishioners at any Catholic church or donate \$100 to St. Francis de Sales School in order to fulfill this requirement and receive the lower tuition rate for the 2020-2021 school year.

All families are encouraged to become active contributing parishioners at a church in order to begin to fulfill the commitment and benefit from a lower tuition rate for the 2020-2021 school year.

Tithing funds will be used to improve building maintenance and curriculum. You will receive a St. Francis de Sales donation letter with our nonprofit tax ID number after we receive your donation. Please consult your tax preparer for information regarding charitable contribution deductions.

2019-2020 School Year Information:

Tuition is due between 1st and 6th of every month. If payment is not processed by the 7th of every month a \$60.00 late fee will be assessed.

****It is not the schools' responsibility to send any family a reminder notice if they have forgotten to pay their tuition. It is the responsibility of each family to pay tuition and any other fees on time. Failure to do so can result in your child/children not being admitted to class and your delinquent accounts being sent to a collection agency. ****

RETURNED CHECKS a NSF fee of \$30.00 will be collected on all returned checks.

Registration Fees

This is a per student fee; Due at time of registration. **\$350**
(Fees cover in part, Diocesan Tax, Insurance, Text Book Use, Renaissance STAR Testing, Material Duplication, Yearbook)

Families who enroll/finalize tuition accounts by June 1, 2019 will receive a \$50 discount

Late Fee

Tuition is considered late after the 6th of the month. **\$60**

All tuition payments made after the 6th will be assessed a late fee unless arrangements were made at the time of registration.

Returned Check Fee

Non-Sufficient Funds (NSF) or stop payment. **\$35**
After 2nd occurrence payments must be made in cash or money order only.

Athletic Fee

Per sport (covers uniform, league membership, Award ceremony) **\$ TBD/Student**

Graduation Fee

Eighth Grade Only. Due before February 1, 2020 **\$100**
(This will cover a portion of Graduation Activities except the field trip.)
8th Grade fundraisers will help offset additional costs

Service Hours

All families are expected to complete **30** hours of volunteer work for the school. (15 hours for single parent families where only one parent is an active participant in the student's life.)

- 15 hrs. per family/7.5 hrs. single parent family due by January 31, 2020 **\$35/1hr**
- 15 hrs. per family. /7.5 hrs. single parent family due by May 1, 2020

Fundraising

All families must participate in various fundraising options throughout the school year. **\$375**

We/I agree to accept all school policies and procedures as outlined in the St. Francis de Sales Catholic School Parental Obligation Contract and the Student/Parent Handbook. We/I are agree to reinforce these school policies and procedures to our child/ren who will also accept them as a student of St. Francis de Sales Catholic School. We/I also understand that the Student/Parent Handbook is an extension of my contract.

We/I agree to the following financial plan for the 2019-2020 school year beginning on June 1, 2019 and ending May 31, 2020.

_____ Registration Fees: We/I understand that the registration fees are per student. These fees certify my child as a student at St. Francis de Sales and cover in part, the cost of Diocesan Tax, Insurance, Text Book Use, Material Duplication, **yearbook**, and Renaissance STAR Assessment.

_____ **Tuition: We/I understand tuition payments begins June 1, 2019 and are paid for 10 or 12 months ending May 1, 2020. ALL accounts must be paid in full by May 1, 2020.**

_____ **Technology Fee: We/I understand the technology fee applies to each student. This fee will be paid through FACTS Management Company. This fee will allow students to access grade specific content**
In the classroom (Licensing, Instructional Technology Resources, Educational Resources)

_____ **Extended Care: We/I understand that extended care requires a separate fee per hour and is charged and billed accordingly once a month.**

_____ **Bishop’s Car Raffle Tickets: We/I understand that ALL families will be required to sell 10 Bishop’s Car Raffle tickets.**

_____ Fundraising Contract: We/I understand that ALL families will be required to select and abide by a Fundraising option. Fundraising obligations will be met in a timely manner according to event dates. If fundraising obligations are not satisfied by May 1, 2020, student will not be eligible for re-registration. **Parents have the opportunity to buy-out their fundraising obligation. The total amount must be paid by December 1, 2019.**

_____ Service Hours: We/I understand that we/I are responsible for **30** hours of volunteer work, (**15** hours for single parent family where only one parent is an active participant in the student’s life) divided equally, the first period ending January 31, 2020. I understand that if I do not fulfill this obligation, I will be billed **\$35** for each unearned hour.

_____ Field Trip Fees: We/I understand that Field Trip fees are per student and may vary according to the trip. Additional fundraising may be necessary to cover field trip costs/additional activities (**\$35 = 1** Service Hour)

_____ We/I understand that parents are responsible for ensuring that students abide by all school policies. (Code of Conduct, Dress Code)

_____ **Any remaining tuition, fundraising and service hour obligations must be satisfied by May 1, 2020 to be eligible for registration for the next school year.**

_____ **ALL accounts must be current for a minimum of 30 days prior to student participation in ANY school sanctioned activity, including independent contracted activities.**
