

**CONTRACTUAL AGREEMENT
BETWEEN
ONEIDA SPECIAL SCHOOL DISTRICT
AND
DARA KLINE, Ph.D., BCBA-D**

GENERAL

The parties of this contract share a mutual concern for providing behavioral management service to children of the Oneida Special Schools. Furthermore, both parties stipulate and agree that the services provided to these children shall be equal to those services provided to other children in the school system.

CONTRACTURAL AUTHORITY

The provisions contained herein are made under authority contained in Part I, Section B, 11, b, (2) of the Rules, Regulations, and Minimum Standards of the Tennessee Board of Education.

This provision authorizes the Commissioner of Education to approve contracts or agreements between local boards of education and suitable agencies or organizations for the provisions of approved facilities and services for children. (TCA 49-2902 and 49-2922).

SERVICES AND FACILITIES TO BE PROVIDED BY ONEIDA SPECIAL SCHOOLS

Oneida Special Schools agrees to contract with Dara Kline, Ph.D. to provide Behavioral Analysis Services for children referred or consultation. This contract will begin on September 6, 2019 and end May 25, 2020. Oneida Special Schools agrees to reimburse Dara Kline at the rate of \$85.00 per hour for a maximum of 58 hours.

Invoices along with all documentation shall be submitted to Oneida Special Schools by the 1st day of each month, with a payment of Net 30 days. Invoices must include the days and hours worked along with teacher/student contact count.

SERVICES TO BE PROVIDED BY DARA KLINE, PHD

Dara Kline, Ph.D., agrees to contract with Oneida Special Schools to provide Behavioral Analysis Services to Oneida Special Schools. Dara Kline, Ph.D. agrees to furnish the necessary materials and expertise in the area of Behavioral Analysis; agrees to furnish all reports and documentation required by Oneida Special Schools.

Dara Kline, PhD and Oneida Special Schools shall at all times comply with the regulations of Title VI, Civil Rights Act of 1964, which prohibits discrimination on the basis of sex, age, color, creed, national origin or mental handicap.

This Agreement constitutes the full understanding of the parties and shall be governed by the laws of the State of Tennessee. This Grant Agreement may be amended only by written instrument signed by authorized officers of Oneida Special Schools and Dara Kline, PhD.
