<u>2019-20</u>	
July 1	Adopted Budget must be filed with the State and County of Los Angeles within five (5) days of Board approval, but no later than July 1.
To Be Determined	Within 45 days after the Governor signs the Annual Budget Act, the District shall make available for public review any revisions in revenues and expenditures that it has made to its budget to reflect the funding made available by the Budget Act (<u>Education Code 42127</u>).
August 14	<u>Board Meeting</u>
August 15	The county superintendent of schools approves or disapproves the budget. If the budget is disapproved, the county transmits recommendations, in writing, to the school district's governing board. The county may assign a fiscal advisor to assist the school district in developing a budget in compliance with the county's revision.
August 15-31	Unaudited Actuals for 2018-19 are prepared.
September 11	<u>Board Meeting</u> - Unaudited Actuals for 2018-19 are presented to the Board. First review of budget based on actuals.
September 25	<u>Board Meeting</u>
October	Conduct needs assessment and involve stakeholders in 2019-20 LCAP goal discussion.

October/November	Annual Audit of District's Financials for 2018-19.
