Mr. McMillan made a motion to approve the agenda. Mrs. Dailey seconded the motion which passed unanimously.

Budget Hearing #1 FY19-20 presented by Bob Hagood was received.

Mrs. Dailey made a motion to approve the following field trips. Trips are funded through WES local school funds:

Woodstock Elementary School's 2nd grade class to travel by charter bus, Landmark Tour and Travel, to Atlanta, GA, on April 9, 2020, to tour the Georgia Aquarium and Atlanta Zoo. Students will depart at 6:00 am and return by 7:00 pm.
