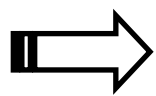
Student Initials Student must notify CCNTH Admin Office of any vehicle change. Failure to do so may result in a parking ticket.

Student Initials **Permission to Leave Campus** - CCNTH is a CLOSED CAMPUS. In order to leave school early a student must obtain a Permit to Leave Campus from the Attendance Office. Refer to the Leaving School Early section of the CCNTH Handbook.

Student Initials ***PARKING AT CCNTH IS LIMITED**, and on a first come first serve basis. Overflow parking is located at NHS in **FRONT OF THE GYM**. *Do not park in front of Olympic Hall at NHS*. You will be ticketed. NO EXCEPTIONS.

Student Initials I have read and agree to abide by the student parking regulations as described in the CCNTH Student/Parent Handbook. I understand that CCNTH is not responsible for any accident, damage or theft to my vehicle. Failure to follow the parking regulations or falsification of any information on this form may result in loss of parking privileges for the school year.

Student Cars/Parking Permits

Driving to school and parking on campus are considered a privilege. Students who wish to drive to school must adhere to the following policies:

1. A vehicle permit application must be filled out and signed by a parent/guardian prior to purchasing a parking permit. Applications are available in the Office. Students must possess and present a valid drivers license and proof of insurance to be eligible for a parking permit. These documents must be presented at the time of purchase.
2. CCNTH has limited parking available for students. Students may not park in areas designated for staff or visitors. **Overflow parking is at Nipomo High School in front of the gym ONLY. Do not park in front of Olympic Hall - you WILL be ticketed.**
3. To be eligible for a parking permit, students must also have good attendance and citizenship, and no outstanding debts to CCNTH or NHS. Excessive tardiness and/or cuts are reason to revoke a parking permit.
4. A \$15 fee is required to obtain a permit for the school year. All monies will go to the ASB fund to defray cost of issuing permits.
5. Students who park illegally or do not have a valid parking permit displayed from the rear-view mirror or windshield inside their vehicle are subject to being ticketed and/or towed.
6. Parking permits are the property of CCNTH and may be revoked at any time. Due to extenuating circumstances, revoked parking permits may be appealed to the principal or designee.
7. Parking along streets adjacent to CCNTH is prohibited. No parking on Mallagh Street.
8. Lending, borrowing, forging or stealing a parking permit may result in the loss of parking privileges for the remainder of the school calendar year, with possible suspension and notification to law enforcement.

General Rules of the Parking Lots

1. Students may not sit in parked cars during school hours. Parking lots are off limits to students unless they are leaving campus after properly checking out, have a signed Permit to Leave Campus Pass, or do not have class for the rest of the day.
2. Cars will not enter or leave the parking lots in a manner which endangers others. **Reckless driving will result in loss of parking privileges.**
3. Theft or damage to a parked car should be reported to the office and/or the NHS School Resource Officer. An accident report should be filed with the police when there is damage to the vehicle or their contents.
4. The school is not responsible for loss and/or damage to vehicles or their contents.
5. The principal/designee has the authority to conduct searches when reasonable grounds exist to suspect that a student has contraband in his/her possession/control or in violation of a rule, regulation or statute. The following regulations apply:

Motor Vehicles - A motor vehicle search shall be defined as any inspection of a motor vehicle. The following regulations apply: 1) The decision to conduct a search of any vehicle on district property may be made by the principal or designee whenever the principal or designee has "reasonable suspicion" that the owner, operator, or other person having access to the vehicle has violated any rule, regulation, or statute; 2) The school official, at his/her discretion, may call upon a law enforcement officer to conduct the search; 3) Vehicle searches, whenever possible, shall be conducted in the presence of at least one adult witness.
