- i. GEA Monthly School Report: Enrollment currently at 242. RSP teacher did a presentation/PD on SLD. Writing Across the curriculum joint PD with GEA 2 held. Two Middle school site visits were set up by Dr. Chou for L. Lee and both of her 5th grade teachers. She feels that the visit at Ramona was very productive. She feels that they picked up strategies that may be utilized in the future if necessary. Working on teachers accessing Lexia and Accelerated Reader. Morning reading has started and was open to K through 5 grade. LAUSD Site visit was held on 11/6/18. We received positive feedback from C. Humphries. 16 students were reclassified which is lower than the amount that was reclassified in the past, but this may be due to the switch to the ELPAC. GEA will hold its first Talent Show in December. CA Dashboard was just released to the public.
