“A person who knowingly or willfully presents to any school district any false information regarding residency of a pupil for the purpose of enabling that pupil to attend any school in that district without the payment of a non-resident tuition charge shall be guilty of a Class C misdemeanor.”
(105 ILCS 5/10-20.12b)

This proof of residency form is to attest that the child listed below is not enrolling in the District solely for school purposes and **is living on a permanent basis with the person having complete custody and control**. Registration of a student who is not a resident is a fraudulent act. Any student found to have been fraudulently registered will be dropped from the attendance rolls immediately. Parents or guardians making a fraudulent registration will be subject to the payment of retroactive tuition charged for non-resident students, not to exceed 110% of the per capita cost.

Category I:

- ___ Most recent property tax bill and proof of payment, e.g. cancelled check for Form 1098
- ___ Rock Island County Assessor's Website/Property Tax Search (<http://www.rockislandcounty.org/TaxSearch>)
- ___ Mortgage paperwork (homeowner)
- ___ Signed and dated lease and proof of last month's payment, e.g. cancelled check or receipts (renter)
- ___ Letter from manager and proof of last month's payment, e.g. cancelled check or receipt (trailer park resident)
- ___ District Form: Letter of Residence from Landlord in Lieu of Lease
- ___ District Form: Letter of Residence to be Used When the Person Seeking to Enroll a Student is Living with a District Resident
