The following is an excerpt from the Board of Trustees Regular Board Meeting held on Thursday, October 18, 2018:

### **16.5. Approve Bid Extension with CDW Government, LLC.**

#### Quick Summary:

The Board of Trustees approved the 2015 Technology Equipment and Peripherals Bid, MSIT3 1-23-2014/15, with CDW Government, LLC, at the 2/19/2015 Board meeting. Section 14 of the Bid states the Contract Period shall be in effect for one calendar year, and that the District may at its option, extend the Bid/Contract for a maximum of four (4) additional years, beyond the original period to maintain the current pricing. It is recommended that the Board approve this fourth and final extension (BS2018/19-18) for one additional calendar year effective January 1, 2019 - December 31, 2019. Designate Teali Fielder as authorized agent for the Board.
