

## NJ TRANSIT STUDENT IDENTIFICATION CARD

- Parents or students shall request a NJ Transit Student Identification Card for discounted transit bus tickets from the school student is attending.
- School shall complete the information requested on the discount card and return to parent or student. **(student and school principal or authorized representative signatures are required).**
- Parents or Students will then go to any of the NJ Transit locations or any approved companies that sell student NJ Transit bus tickets and present the completed card to agent in order to purchase the discounted tickets.
- Please be reminded that the Student Identification Cards are dated and expire at the end of each school year. The color of the Student Identification card is changed from one year to the next.



### NJ TRANSIT The Way To Go **STUDENT IDENTIFICATION CARD**

The student whose name appears below is entitled to purchase Student Tickets when this card is signed by student and countersigned by the principal or authorized representative of school attended by student. Individual sales of Student Tickets are limited to not more than six sets of 10 tickets at any one time. Student tickets are valid for continuous rides on certain NJ TRANSIT lines. Student, when requested, must present Student Tickets and this card for examination by operator or other representative of the Company. This card is not transferable and shall be forfeited if presented by any person other than the student named hereon or for violation of any of the foregoing conditions.
