- I am accountable for my device at all times and take full responsibility for all damages or loss.

- The device should not be left unattended at any time or used near water.

- I am not to delete any school installed application or software on the device.
- I am to follow the IWCS Acceptable Use Policy at all times.
- I am to bring my device to school fully charged each day.
- I am to report any damage, theft, loss or vandalism to school administration immediately.
- I must report any knowledge of inappropriate use of my device to a school designee.
- I agree to return the device, case, charger and power cords in good working condition at the end of the school year, upon leaving IWCS or when my user privileges are revoked.
