# Pendleton P.A.W.S. School Behaviors

All school-wide behaviors can be classified under three general categories. These categories are as follows:

**Above the Line**: When the student is following all Pendleton P.A.W.S. expectations, we will say that they are exhibiting "Above the Line" behaviors.

Above the Line behavior will be rewarded throughout the year. Rewards may include, but are not limited to:

- □ P.A.W.S. tickets given by staff members
- □ SUPER P.A.W.S. tickets given by substitute teachers & worth 3 P.A.W.S. tickets
- Positive Behavior Office Referrals given by staff members

Above the Line events will be held throughout the year for students who have earned the required number of tickets.



**Below the Line:** When the student is not displaying expected P.A.W.S. behaviors, the student is behaving Below the Line. We will remind them that they need to check their behavior. These behaviors will be dealt with following the P.A.W.S. consequences.

#### P.A.W.S. Consequences

Below the Line: 1. Verbal Warning

2. Written Reflection

3. Loss of Privileges

4. Parent Contact

Bottom Line: 5. Office Referral



**Bottom Line**: If steps 1-4 of the P.A.W.S. Consequences have been completed, and the student continues to violate the expectation, the student is displaying "Bottom Line" behavior and an office referral is made.

However, there are certain behaviors that will result in the student skipping the P.A.W.S. Consequences procedure. This student's behavior will automatically be classified as "Bottom Line" and will be referred directly to the principal. These types of behaviors include:

- Abusive/Threatening language
- Harassment/Bullying/Threats/Intimidation
- Physical aggression/Fighting
- Lying/Cheating
- Property damage
- Forgery/Theft
- Truancy
- Possessing a firearm, knife, explosive, or other dangerous object
- · Possessing or using any controlled substance
- Possessing an imitation firearm
