We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2017-2018 educational progress for Kelloggsville Public Schools and our schools. The AER addresses the complex reporting information required by federal and some requirements of state laws. The District's report contains information about student assessment, accountability, and teacher quality. Our staff is available to help you understand this information. Please contact Mrs. Tammy Savage, Assistant Superintendent for help if you need assistance.

These reports contain the following information:

Student Assessment Data

Includes the following three assessments:

- M-STEP (Michigan Student Test of Educational Progress)
- MI-Access (Alternate Assessment)
- College Board SAT

Present assessment information for English language arts and mathematics for grades 3 to 8 and 11, and science for grades 4, 7, and 11, compared to state averages for all students as well as subgroups of students. The report helps users to understand achievement performance within grades and schools, and to make comparisons to district, state, and national achievement benchmarks.

Accountability Scorecard – Detail Data and Status

The accountability portion of the AER includes assessment proficiency and participation rates, graduation or attendances rates, as well as accountability index values showing school performance on a 0-100 scale.

Teacher Qualification Data

- Identifies teacher qualifications at district and school levels.

- Reports percentage of core academic classes taught by teachers not considered highly qualified to teach such classes.

NAEP Data (National Assessment of Educational Progress)

- Provides State results of the national assessment in mathematics and reading every other year in grades 4 and 8.

Review the table below listing our schools. For the 2017-18 year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no status label is given.

Note TSI and ATS definitions were changed for the 2018-19 school year per federal requirements. The new definitions are:

- TSI – The school has at least one subgroup performing in the bottom 25% within each applicable accountability index component.
- ATS – The school has met the criteria for TSI identification and has at least one subgroup performing at the same level as a CSI school.

School Name	Status Label	Key Initiative to Accelerate Achievement
East Elementary	No Label	Staff will use research based practices to improve the learning of students in areas identified by data analysis.
West Elementary	No Label	Staff will provide evidence/research-based instruction to all students.

Southeast Elementary	No Label	Staff will develop a common language for instruction and effectively use a common set of instructional strategies to increase student achievement.
Kelloggsville Middle School	No Label	Staff will implement a gradual release model to improve student achievement.
Kelloggsville High School	No Label	Staff will seek training to integrate available technology into the classroom to increase student engagement and achievement.
54 th Street Academy	No Label	Staff will use research-based strategies to deliver effective instruction on credit recovery in a non-traditional learning environment.
