

RE: SCHOOL ASSISTANCE IN FEDERALLY AFFECTED AREAS

Dear Parent or Guardian:

The Lemon Grove School District receives support through the Federal Impact Aid Program to financially assist the District due to lost property tax revenue for federally owned property within its boundaries. We ask that you return the survey form on the reverse side of this letter regarding your employment as of November 26, 2018. Special attention is needed if you are employed in one of the following groups:

- **Active Military** – Please indicate Branch of Service and Rank, Ship, F.P.O. or A.P.O. designations. Please Note: Parents must be ACTIVE military, not retired. Parents must write out the name of the federal property.
- **U.S. Government (Civilian Employees)** – If you work at or on government-owned property, please indicate the name and address of the property. If you work on a ship, please provide the name of the ship, hull number, and port.

It is essential that we have a survey form signed and dated by a parent for each student. Please be sure to state if you live on federal property, as the reimbursement rate is more favorable for your student's education.

The information you give us is strictly confidential, except for auditing by federal authorities. Your cooperation in completing the survey form and returning it to your child's school by November 30, 2018, is sincerely appreciated.
