VERIFICATION OF RESIDENCY

Any person who knowingly enrolls (or attempts to enroll) a pupil known by that person to be a non-resident of District on a tuition-free basis, or any person who knowingly or willfully presents any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in District 103 without the payment of a non-resident tuition charge shall be guilty of a class C misdemeanor. Anyone who knowingly or willfully provides false information on this form shall be referred for criminal prosecution. Only the parent/legal guardian will be allowed to register the student.

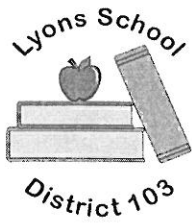

Proof of Residency Form
