PARKING TAGS FOR 2018-2019 SCHOOL YEAR

ALL STUDENTS wanting a parking tag for the 2018-2019 school year will be asked to fill out a **NEW VEHICLE REGISTRATION CARD** for each vehicle to be driven to school and parked in the student lot.

YOU MUST BRING WITH YOU:

- YOUR CURRENT DRIVER'S LICENSE
- CURRENT DMV REGISTRATION SLIP/OR BILL OF SALE (FOR NEW VEHICLES)
- CURRENT PROOF OF CURRENT INSURANCE
- I.D. CARD

You must have completed the Smart Start Class before you can obtain a parking permit. For additional information please contact Mr. Gregory.

You may register as many vehicles as you wish, as long as they belong to your family. *Fill out a card for each vehicle*, and bring the above mentioned items to the Cashier.

You will be issued one (1) tag – this tag will be recorded to all vehicles you register. You must display this tag from the rearview mirror of whichever car you drive that day. Replacement tags can be obtained with a cost of \$1.00.

REMEMBER – YOU MUST REGISTER EACH VEHICLE. YOU WILL BE TICKETED IF YOUR TAG DOES NOT MATCH THE CAR IT IS PLACED IN! (You need to fill out another vehicle registration card)

If you need to drive a vehicle that is not registered at this school, then you must get a temporary parking permit - obtained from Security. This temporary permit is good only for the time indicated, usually just one or two days. **YOU SHOULD GET THIS FIRST THING IN THE MORNING, before the first bell – OR THE DAY BEFORE IT IS NEEDED.**

If for some reason you receive a ticket and feel it is in error, you must take the ticket to the Assistant Principal's office to discuss it within 10 days of receipt.

ISSUANCE OF A STICKER/TAG DOES NOT GUARANTEE A PARKING SPOT. PARKING SPOTS IN THE STUDENT LOT ARE AVAILABLE ON A FIRST COME, FIRST SERVED BASIS.

Student parking is provided on a limited basis and as a *convenience* to our SP students. **The school is not responsible for theft or damage to vehicles parked on school grounds.** All vehicles parked on school property are subject to search. Each registered student is responsible for all contents contained in his/her vehicle – including contraband. All motor vehicles must be registered with the SP Cashier. Each driver will be required to present a valid California's driver's license, Department of Motor Vehicle registration and proof of insurance. Vehicles parked on campus must display a valid parking permit. **Student vehicles not displaying a permit will be cited.** Security is not always provided – park at your own risk.

Unsafe Driving –

Students must drive safely at all times in the school parking lot. Any driving by a student that is deemed “unsafe” may immediately result in the loss of a parking permit for the remainder of the school year.

Excessive Tardies –

All students and parents who apply for a parking permit application understand that as part of the convenience and privilege of parking on our campus, it is the student's responsibility to be on time to class. If a student receives 8 morning tardies (per semester) the parking permit will no longer be valid and they will lose their parking permit for the remainder of the school year.

Temporary parking Permits -

If students have temporary use of another vehicle and would like to apply for the privilege of a temporary parking permit, they must obtain a temporary permit before 7:30 a.m. from morning security staff in the parking lot. It must be placed in the vehicle before the school day begins. **All non-permitted vehicles in the parking lot are subject to a parking ticket.**
