## Senior “LUNCH PERMIT” Contract



**SUBMIT AT STATION 3**

Dear Senior Student and Parent:

Seniors who would like to participate in the “Lunch Permit” program must have their parent’s permission regardless of age. Those students wishing to participate in the “Lunch Permit” program will be issued a special student body card, **which must be shown to the proctors each day before leaving campus.** The objective of having a “Lunch Permit” program is to give seniors the opportunity to demonstrate additional levels of responsibility within the parameters of school and city regulations. Any infractions of the guidelines set forth in this agreement and/or in the Student/Parent Handbook (such as taking unauthorized students off campus, vandalism, tardiness, truancy, loitering on campus or adjacent property) will be justifiable cause for revoking the “Lunch Permit” privilege. **If for any reason your lunch permit is revoked, you will be issued a new ID card without “Lunch Permit” denoted at a \$10.00 replacement cost to you.** Seniors with a “Lunch Permit” **must return to school after lunch and attend classes the remainder of the day or the student will be considered “truant” unless an off-campus permit has been obtained from the Attendance Office before leaving for lunch.**

As a participant, whether student or parent, we wish to call your attention to the seriousness of giving permission for a “Lunch Permit” pass. We suggest a family conference in which the pros and cons are carefully discussed. Parents may request to have the “Lunch Permit” privilege revoked at any time during the school year by contacting the Deans’ Office at 626-821-1759. *If a permit is not going to be needed, please do not sign below and do not return this form.*

The school staff will be diligent in supervising the lunch program during the course of the school year. Any violation of school policy on or off the campus will be cause for disciplinary action and/or revoking the “Lunch Permit” privilege. If you have any questions, please contact the Deans’ Office at 626-821-1759.
