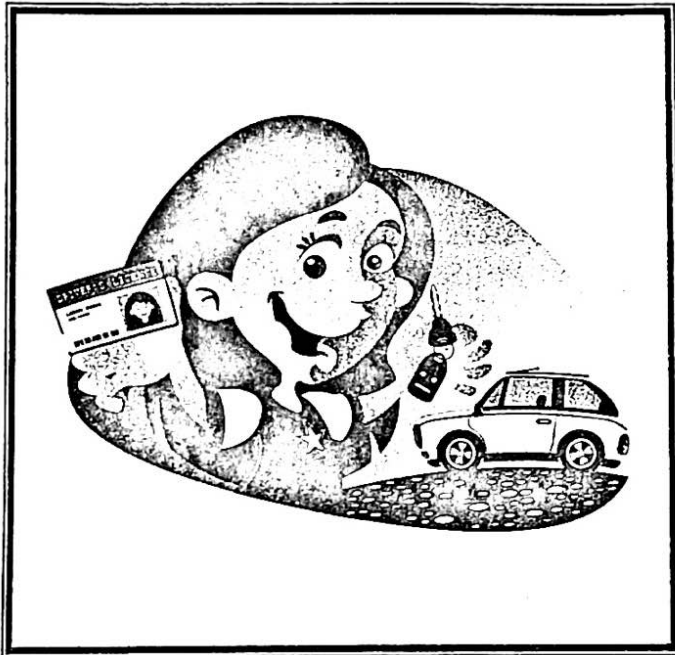


STUDENT DRIVING INFORMATION

RULES AND REGULATIONS

For our student drivers

1. Students who drive cars to school are required to purchase a parking permit. Students must provide **valid driver's license, license plate number, proof of insurance, and vehicle registration**. Parking permits will cost \$10.00.



2. **Parking Stickers** must be placed on the Bottom Passenger side of back glass of vehicle.

3. Vehicles without parking permits will not be allowed to park in the student parking lot. **Vehicles without parking permits will be towed.**

4. **Student Parking Areas:** All students must park in the front of Marksville High School on the New limestone student parking lot (*in the middle of staff/visitor parking*).

5. **Off Limit Parking Areas:** Parking in the faculty parking lots is not permitted (front of the school, within the gate between 8th grade building and Ag building, around Tennis Court or Softball Field). If you park there, your car will be towed.

6. Failure to follow parking rules will be subject to disciplinary actions, and will result in loss of parking privileges.

7. Students between the ages of 15 and 18 must be in regular attendance and must have a GPA of at least 1.0 as a condition of receiving or maintaining a driver's license for driving privileges (Act 648, 1989 Legislature).

8. A "school withdrawal" form shall be completed on any student between the ages of 15 and 18 who withdraws voluntarily or involuntarily (expulsion or incarceration) and is subject to the compulsory attendance laws of the state of Louisiana(13 unexcused absences). Withdrawal forms are forwarded through the central office to the Office of Motor Vehicles in Baton Rouge for the purpose of cancelling driving privileges and surrendering license to same (Act 648, 1989 Legislature).

I understand that should my specimen indicate the abuse or misuse of legal or illegal substances, I will be subject to action specified in the *Avoyelles Parish School Board Student Drug Policy*.

I, _____, parent/guardian of the undersigned student, individually and on behalf of my child, do hereby grant permission for and consent to said child being tested for substance abuse/misuse in accordance with his/her *Avoyelles Parish School Board Student Drug Policy* and I understand that if any specimen taken from him/her indicates abuse or misuse of legal or illegal substances, including anabolic steroids and other performance enhancing drugs, he/she will be subject to action specified in the *Avoyelles Parish School Board Student Drug Policy*.
