Dear CBC Parents

Let us remember that we are in the holy presence of God. This call to worship is an integral part of our everyday life at CBC. We are truly blessed with an incredibly dedicated and committed faculty and staff and a student body that is second to none. Thank you for the trust you have placed in us by allowing us “to touch the hearts and teach the minds” of your son(s) as directed to us by De La Salle.

The Board of Directors of Christian Brothers College High School has set tuition for the 2019 – 2020 academic year. Tuition will be \$15,925.00, plus an additional \$1,475.00 for technology and fees. The total cost for attending CBC during the 2019 – 2020 school year will be \$17,400.00.

Attached please find the tuition contract for next year. The tuition contract, along with a \$500.00 deposit for sophomores, juniors, and seniors, must be submitted to CBC by **March 15**. For incoming freshmen, a \$600.00 deposit and completed tuition contract must be submitted to CBC by **March 1**. This deposit ensures your son’s enrollment in CBC for the upcoming school year.

While tuition and fees have been set at \$17,400.00, the full cost of educating your son(s) at CBC is actually \$18,805.00, resulting in a tuition gap of \$1,405.00, which must be made up through the giving of others, including our parents, who are able. Please consider making a tax-deductible donation to cover this tuition gap. On the tuition contract, there is a section to complete indicating your “gap” donation. We would love if you could pay the full amount, but any gift your family can afford would be greatly appreciated.

We will soon be working on need-based financial aid packages for next year. This year we were able to distribute \$2.6 million to families who qualified for need-based assistance. We will strive to do the same for the 2019 – 2020 school year.

Thank you for your continued support of Christian Brothers College High School. The generosity of the CBC community never ceases to amaze us. Through your generosity, we are able to continue doing the work of our Lord and Saint John Baptist de La Salle by helping those most in need. May God continue to bless you most abundantly for the good you do for others.

Registration Deposit and Tuition Contracts:

Class of 2023 - \$600 deposit and tuition contracts are due March 1.

Class of 2020, 2021, 2022 - \$500 deposit and tuition contracts are due March 15.

- Is a **non-refundable** deposit applied towards tuition. It is not an amount in addition to tuition.
- Payable by check only.

Tuition Contract: \$17,400 in total.

- The contract total consists of tuition of \$15,925.00 and laptop & fees of \$1,475.
- The contract does not cover the cost of books. Your son will be expected to pay his book bill by check or credit card at Orientation in August.

The following items need to be returned to the CBC Finance Office by the due date:

- 1) Submit a check to the finance office for the registration deposits due for each of your sons that will be attending CBC for the 2019/2020 school year.
- 2) Complete the **Tuition Contract** (2 pages), selecting a payment plan for the tuition and fees due for 2019/2020. **Families with more than one son attending CBC should complete only one contract, listing all sons enrolling for 2019/2020.**
- 3) Complete the **Responsibility Party Form** and return to the Finance Office along with the Tuition Contract and registration deposit.

Tuition Payment Plans:

Single Payment Option

- **Option # 1:** Payment by check to the CBC Finance Office by August 1, 2019. You will be sent an invoice July 1. *** Please note there is no discount for single payment in full.**
- **Option # 2:** Payment by credit card. The CBC Finance Office will send an invoice July 1 with a detailed calculation of the balance due after the application of the 2.5% credit card processing fee. Your credit card payment will be processed on August 1, 2019.

Multiple Payment Options: *Administered through Smart Tuition, enrollment fee paid by CBC.*

- If you currently have a CBC Tuition account through Smart Tuition and you are not changing the method of payment, you **do not** need to complete a Smart Tuition contract. On the CBC tuition contract, select the option of "I am currently enrolled in Smart Tuition" and your existing account will be rolled over for 2019/2020.
- If you are not currently enrolled in Smart Tuition, select the option of "I am not enrolled in Smart Tuition" and complete the Smart Tuition contract. Please attach a voided check.

Tuition Policy

(As Approved by the CBC High School Board of Directors)

1. Tuition and laptop lease payments will be collected by CBC or a 3rd party processor selected by CBC:
 - a. Those who choose to pay the tuition and laptop annual fees in full may do so by submitting payment directly to CBC High School, Finance Department by August 1.
 - b. Those who choose alternate payment plans must sign up for the automatic withdrawal or credit card payment plan offered through **Smart Tuition**, a third party processor.
2. Tuition assistance and scholarships will be credited at the time of determination and payment plans will be adjusted accordingly.
3. A fee of \$25 will be charged for all returned checks and credit card charges processed by the CBC finance office.
4. All charges of tuition and fees must be **paid in full by the 1st of May** of the applicable school year. Students advancing to the next highest grade will not be considered registered for that grade until all prior tuition and fees are paid in full. Schedules and booklists will not be issued and the student will be placed on financial probation.
5. Registration for the **coming year is due on March 1st for the Class of 2023 and March 15th for the Classes of 2020, 2021, and 2022**. Students will not be considered registered for the coming school year until their registration is paid. Schedules and booklists will not be issued, and report cards will be held for current students.
6. The following will apply to those students whose registration, fees and tuition are not current:
 - a. Report cards will be held.
 - b. The student will not be allowed to attend classes or take final exams.
 - c. Transcripts will not be released unless the student's account is paid in full at the time the transcript is requested.
 - d. Diplomas will not be released.
 - e. The student will be placed on financial probation.
7. For parents who share financial responsibility, the above policies apply to both parents' portion of the student's tuition account. Both parents must make all of their scheduled payments on a timely basis.
8. Parents with delinquent accounts will be expected to communicate with the Business Office to resolve the issue. Failure to respond to such a request will result in holding of laptop and immediate suspension of the student.
9. **No student will be allowed to attend CBC for whom we do not have a signed tuition Contract in place.**

There must be a signed tuition contract.

TERMS AND CONDITIONS

Smart Tuition receives, processes and deposits your payments into your school's bank account. Our secure website and 24/7 parent help center are available to families that have questions about their tuition payment plans.

Late Enrollment: If Smart Tuition does not receive your enrollment form on time, your first payment date will be moved forward. Your school may require you to catch up any missed payments on your first due date or may establish a plan with a smaller number of larger payments.

Refunds: Smart Tuition does not issue cash refunds. Overpayments will be carried on your account and credited to future tuition payments. All reimbursements or refunds must be arranged with your school.

Follow Up Fees: Any payment that is not received by Smart Tuition by your due date is considered late and may receive a follow up fee. In the event that your account becomes delinquent, Smart Tuition may provide your school a follow up service which will contact you via mail, telephone, or e-mail. Your account may be charged \$40.00 as a result of this service. This fee is in addition to any late fees charged by your school.

Dishonored Payments: A fee of \$30.00 will be applied to your account for any failed auto-debit and failed check payments. Your bank may impose additional fees.

Auto-debit Terms (Applies to auto-debit enrollees only): By signing this enrollment form you agree to authorize Smart Tuition to debit your account on the scheduled dates as described on the reverse side. If your auto-debit due date falls on a weekend or holiday, your account will be debited on the following business day. You agree that if any such debit is dishonored, for any reason, Smart Tuition shall have no liability for any fees charged to you by your financial institution. Smart Tuition will automatically reattempt any failed debits approximately 10 days after their failure. This authority will remain in effect until Smart Tuition receives your written instruction to cancel auto-debit service. To cancel or stop a scheduled auto-debit payment, you must contact Smart Tuition no later than 3 business days prior to the scheduled payment at **(888) 868-8828**.
