PLEASE TAKE NOTICE that Richard Kipperman, as Receiver (the "Receiver") duly appointed in the matter of *People of the State of California v. McManus*, Case. No. SCD266439 (the "Case"), pending in the Superior Court of the State of California for the County of San Diego (the "Court"), exercising authority granted pursuant to the permanent Order entered July 15, 2019, by the Court in the Case, has elected to close the charter school known as University Prep San Bernardino, CDS # 36-67892-0138321 (the "School") effective immediately.

Schools or school districts requesting student records to be sent directly to a new school of enrollment may request student records by faxing a request to 855-636-0544.

All requests for student records must be received on or before August 20, 2019. The Receiver intends to transfer each student's records to the student's school district of residence on or about September 30, 2019, and thereafter parents, guardians, schools or school districts may request copies of the student's records from such district.

High school transcripts may only be requested online through Parchment.com. Transcript requests may take up to 10 business days to process. The progress of a transcript request can be tracked in the Parchment.com account.

Parents, guardians, and students should contact the student's school district of residence for assistance in locating suitable alternative programs.
