### General Information

**Title 1** is a federal grant to meet the **Special Educational Needs of the Educationally Deprived Children under Title 1 of Public Law 107-110**. The funds provided enable Hannah-Pamplico Elementary/Middle School to provide opportunities for children to acquire the knowledge and skills to meet the state performance standards. These opportunities are outlined in a school-wide plan that includes a comprehensive needs assessment, professional development, reform strategies and a description of how the funds will be utilized.

### Parent's Right to Know

As a parent of a student enrolled at Hannah-Pamplico Elementary/Middle School, you have the right to know the professional qualifications of the classroom teachers and instructional assistants who instruct your child. Federal law allows you to ask the following information about your child's classroom teachers and requires the district to give you this information in a timely manner:

- Whether the teacher/paraprofessional has met the South Carolina certification requirements for the grade level and subject area(s) in which the teacher provides instruction.
- Whether the teacher is teaching under an emergency or other provisional status through which South Carolina qualifications or certification criteria have been waived.
- The college major and any graduate certification or degree held by the teacher.
- Whether the student is provided services by paraprofessionals, and if so, their qualifications.
