
BACKGROUND AND INFORMATION

In 2004 Bensalem Township School District started developing plans to construct a Gymnasium on the Bensalem Township High School Grounds to eliminate the need to use Armstrong Middle School.

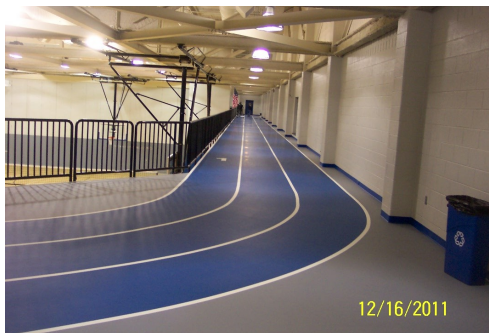
Project Budget was set at \$10 Million. As plans evolved the project cost reached \$14 Million to achieve all the faculties requirements.

The School Board being aware of the Township's plans to construct and operate a Township Community Center, entered into an agreement between the two Governmental bodies to apply the township funds and a state grant in the combined amount of \$4 Million to the project.

In exchange for the combined funds it was agreed that the new gymnasium would provide the Township with a limited use Community Center for Bensalem residents.

The Township use of the Gymnasium for the Community Center is defined by a mutually agreed to Use Agreement.

Bensalem Township School District is working to bring the Community Center Use to fruition.

AVAILABILITY OF FACILITIES

A. During emergency and snow closing all activities will be canceled, and no activities will be permitted during Holiday shut-downs.

B. Community Center facilities will not be available for use during the duration of a strike by security and/or custodial employees of the School District.

C. Community Center facilities shall become available at 6:00 PM and be vacated by 9:00 P.M on designated weekdays.

Saturday availability upon request will be from 9:00 AM to 12:00 PM and there shall be no Sunday activities.

D. On or before July 15th of each year, the appointed representative of the School District shall determine scheduling dates and activities for the Community Center facilities for the upcoming activities year commencing September 1st.

E. Community Center may not use facilities during normal school hours during the regular school year.

F. School District shall designate a person responsible for scheduling activities at Community Center

SCHOOL OFFICIALS

A. School officials shall have the authority to engage security personnel and call police when, in their judgment, it is necessary.
