BACKGROUND INFORMATION:

Education Code section 45246 (c) states in part, “Where a system is already in existence and a vacancy will exist on December 1, by not later than September 30...The appointee of the governing board and the appointee or appointees of the classified employees shall publicly announce the name of the person they intend to appoint, if the vacancy is their appointee.”

The term for Commissioner Diana Souza, who is the jointly appointed Personnel Commissioner, will be expiring on November 30, 2019. In accordance with Education Code section 45246, the Personnel Commission shall publicly announce the name of the person they intend to appoint or reappoint.

RECOMMENDATION:
