

# Oneida Board of Education

Attendance is a key factor in student achievement and therefore, students are expected to be present each day school is in session.

The attendance supervisor shall oversee the entire attendance program which shall include:<sup>1</sup>

1. All accounting and reporting procedures and their dissemination;
2. Alternative program options for students who severely fail to meet minimum attendance requirements;
3. Ensuring that all school age children attend school;
4. Providing documentation of enrollment status upon request for students applying for new or reinstatement of driver's permit or license; and
5. Notifying the Department of Safety whenever a student with a driver's permit or license withdraws from school.<sup>2</sup>

Student attendance records shall be given the same level of confidentiality as other student records. Only authorized school officials with legitimate educational purposes may have access to student information without the consent of the student or parent/guardian.<sup>3</sup>

Absences shall be classified as either **excused or unexcused as determined by the principal** or his/her designee. Excused absences shall include:

1. Personal illness;
2. Illness of immediate family member;
3. Death;
  - a. In the family: One day will be excused. Additional days will be excused at the discretion of the principal.
  - b. Of others: The principal may approve as an excused absence with appropriate documentation.
4. Extreme weather conditions;
5. Religious observances;<sup>4</sup>
6. Circumstances which in the judgment of the principal create emergencies over which the

1 student has no control; or

2 7. Only three per occurrence can be excused because of lice infestation.

3  
4 A total of five (5) excused absences for a full day absence per semester will be allowed through the use  
5 of parent or physician notes. Excuses must be submitted within five (3) days after the student returns  
6 to school.

7  
8 The principal shall be responsible for ensuring that:<sup>5</sup>

- 9  
10 1. Attendance is checked and reported daily for each class;  
11 2. Daily absentee sheets contain sign in/sign out sheets and indicate students present or absent  
12 for the majority of the day;  
13 3. All student absences are verified;  
14 4. Written excuses are submitted for absences and tardiness;  
15 5. System-wide procedures for accounting and reporting are followed.

## 16 17 **TRUANCY**

18  
19 Truancy is defined as an absence for an entire school day, a major portion of the school day or the  
20 major portion of any class, study hall or activity during the school day for which the student is  
21 scheduled. Students who are absent five (5) days without adequate excuse will be reported to the  
22 director of schools who will, in turn, provide written notice to the parents/guardians of the student's  
23 absence.<sup>5</sup> If a student is required to participate in a remedial instruction program outside of the regular  
24 school day where there is no cost to the parent(s) and the school system provides transportation,  
25 unexcused absences from these programs shall be reported in the same manner

26  
27 The Board shall determine annually and include in the school calendar a plan for using three (3) abbre-  
28 viated school days and the procedures for making up missed instructional days. In addition, the Board  
29 shall determine annually whether to use flexible scheduling for kindergarten students.

30  
31 Students participating in school-sponsored activities whether on- or off-campus shall not be counted  
32 absent. In order to qualify as "school-sponsored," the activity must be school-planned, school-  
33 directed, and teacher-supervised.<sup>6</sup>

## 34 35 **MILITARY SERVICE OF PARENT/GUARDIAN**

36  
37 School principals shall provide students with a one-day excused absence prior to the deployment of  
38 and a one-day excused absence upon the return of a parent or custodian serving active military service.  
39 Principals shall also allow up to ten (10) excused cumulative absences per year for students to visit a

1 parent or guardian during a deployment cycle. The student shall provide documentation to the school  
2 as proof of his/her parent's/guardian's deployment. Students shall be permitted to make up schoolwork  
3 missed during the these absences.<sup>8</sup>

### 5 **MAKE-UP WORK**

6

7 All work during any absence should be made up. The responsibility for arranging any make up work  
8 following an absence is the responsibility of the student. Arrangements for make-up work must be  
9 made on the first day after returning to school. The number of days allowed for make-up work will be  
10 determined by the teacher; however, it will be no less than the number of days which the student  
11 missed.  
12

13 A grade not made up will be replaced with a zero for the purposes of averaging grades. Teachers may  
14 give a grade of incomplete if they feel a student is unable to complete the work due to circumstances  
15 beyond the student's control. It is the student's responsibility to make arrangements with the teacher to  
16 complete the work prior to the end of the following grading period, or the incomplete will be changed  
17 to reflect a failing grade. The teacher will present, in writing, the new grade to the secretary who will  
18 post it on the student's record.  
19

### 20 **STATE MANDATED TESTS/ END OF COURSE EXAMS**

21

22 Students who are absent the day of the scheduled End of Course exams must take the test on the make-  
23 up day and present a signed doctor's excuse or must have been given an excused release by the  
24 principal prior to testing to receive an excused absence.  
25

26 Students who have excused absences will be allowed to take a make-up exam developed by the teacher  
27 that will count as 25% of their grade. (This does not satisfy Gateway requirements.) Excused students  
28 will receive an incomplete in the course until they have taken the Gateway test. Students who have an  
29 unexcused absence shall receive a failing grade on the course exam which shall  
30 be averaged into their final grade at 0%.  
31

32 All students who miss a scheduled Gateway Test must take the test at the next administration in order  
33 to meet their Gateway diploma requirement.  
34

### 35 **CREDIT/PROMOTION DENIAL**

36

37 Credit/promotion denial determinations may include student attendance, however student attendance  
38 may not be the sole criterion.<sup>9</sup> However, if attendance is a factor, prior to credit/promotion denial, the  
39 following shall occur:

- 2 1. Parents and students shall be advised if a student is in danger of credit/promotion denial due to
- 3 excessive absenteeism.

- 5 2. Procedures in due process are available to the student when credit or promotion is denied.

## 7 **DRIVER'S LICENSE REVOCATION** <sup>2</sup>

8

9 More than ten (10) consecutive or fifteen (15) reported absences (excused or unexcused) by a student

10 during any semester renders a student ineligible to retain a driver's permit or license, or to obtain such

11 if of age.

12

13 In order to qualify for reclaiming a driver's permit or license, the student must make a passing grade in

14 at least three (3) full unit subjects or their equivalency at the conclusion of a subsequent grading

15 period.

## 17 **ATTENDANCE REQUIREMENTS, TARDINESS and MISSED CLASS PERIODS**

18 Students in grades K-12, accumulating time for unexcused tardiness or excessive excused tardiness (at

19 discretion of principal) which is defined as sign-outs or late sign in of 5 or more times at any time

20 during the year will be required to attend Saturday School. Students in grades k-8 having absences or

21 accumulated time of 30 or more days per year for k-8 (12 days for high school per semester) will be

22 retained in their present grade or required to attend after school tutoring and or summer school to make

23 up missed work. Students who have missed 10 consecutive days due to health issues, and are seeking

24 homebound services are required to have their case reviewed at the building level with the principal

25 and must provide medical documentation showing request of homebound services from their

26 physician. State law requires that all children through age 18 be enrolled in school. Regular attendance

27 is essential to your child's success.

## 28 **CLASS PERIODS MISSED**

29 **Oneida High School Students, in grades 9-12 attend 90 minute block schedule classes for all**

30 **courses offered. Students who are absent for four unexcused block class periods in a semester**

31 **will be referred to the school district's attendance supervisor by the principal. Oneida High**

32 **School students, who are absent for six unexcused 90 minute block periods may be referred to**

33 **Scott County Juvenile Truancy Court.**

34 **Oneida Middle School Students in grades 6-8, attend five, 55 minute core classes during a school**

35 **day. Students who are absent for 6 unexcused class periods in nine week period, will be referred**

36 **to the school district's attendance supervisor by the principal. Oneida Middle School students,**

37 **who are absent for 9 unexcused class periods may be referred to Scott County Juvenile Truancy**

38 **Court.**

## 1. Personal illness

- a. Only five (5) days, whether consecutive or not can be excused by a parent note or doctors excuse per semester (Semesters will run August – December and January – May); All Sign In and Sign Outs are automatically counted as a parent note. Every day of absences equals one parent note. Notes should include student's name, date(s) of absence(s), reason for absence, signature of parent and a phone number where a parent can be reached.

Absences that do not meet any of the criteria listed above in items 1-7 will be considered unexcused.

**An example of an unexcused absence is a family vacation taken during the school year.** Please try to schedule vacations during summer, fall, Christmas or spring breaks. The criteria listed above in items 1-7 will also apply to tardies and early dismissals.

Parents/Guardians of students who are absent **five (5)** days without adequate excuse will receive written notification in the form of a letter of the student's absences. Upon **eight (8)** unexcused absences, a referral will be made to the Attendance Supervisor. The attendance supervisor will then contact the parent(s)/guardian(s) to schedule a meeting with the Truancy Board. This hearing is an attempt to **avoid** a truancy petition in Scott County Juvenile Court System.

## TARDINESS

Sign-outs / late sign-ins will be dealt with at the building level. Refer to each schools handbook for the building policy on tardiness.

## ATTENDANCE HEARING

An attendance committee appointed by the principal will conduct a hearing to determine if any extenuating circumstances exist or to determine if the student has met attendance requirements that will allow him/her to pass the course or be promoted. Upon notification of the attendance committee decision the principal shall send written notification to the director of schools/designee and the parent(s)/guardian(s) of the student of any action taken regarding the excessive unexcused absences. The notification shall advise parent(s)/guardian(s) of their right to appeal such action within two (2) school days to the director of schools/designee.

The appeal shall be heard no later than ten (10) school days after the request for appeal is received. Within five (5) school days of the director of schools/designee rendering a decision, the student's parent(s)/guardian(s) may request by the Board, and the Board shall review the record. Following the

1 review, the Board may affirm or overturn the decision of the director of schools/designee. The action  
2 of the Board shall be final.

3 The director of schools/designee shall ensure that this policy is posted in each building and  
4 disseminated to all students, parents, teachers, and administrative staff.

5 Any administrative decision regarding attendance may be appealed initially to the director of schools  
6 and ultimately the Board. The appeal shall be made in writing to the director of schools within five (5)  
7 days following the action or the report of the action, whichever is later.
