Strother moved to proceed with the application of the K-4 EOC Funding Opportunity. The motion was seconded by Mrs. Priester. The motion was passed unanimously.

Dr. Wilcox will carry the Election Policy to the Board of Election Office.

Dr. Wilcox will work on a plan for maintaining the Athletic Fields.

Mrs. Priester moved to enter into executive session to discuss a student discipline matter, personnel matter, and a legal issue. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

The Board reconvened in Open Session.

Open Session

Mrs. Murdaugh moved on behalf of the Board I present a motion to approve the recommendation of Dr. Wilcox to hire Ron Youmans for the position of Adult Ed Director. Mrs. Priester seconded the motion. The motion was passed unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to approve the \$94,306 additional funding for Career Specialists. The funding will be used to meet the needs of 6<sup>th</sup> grade students and Wade Hampton High School students. Mrs. Priester seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to approve the purchase of two used school busses. One will be used for activities; the other as a spare bus. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to accept the bid of \$2,000 for surplus property submitted by Larry Bishop of Open Arms Fellowship. Mrs. Priester seconded the motion. The motion was

adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to accept the bid of \$15,800 for the Fennell gym floor by Floor Woods Hardwood Floors. Mrs. Priester seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to accept the bid of \$7,400 for roof replacement at Fennell Elementary Art Building by Elmer McQuire. Mrs. Priester seconded the motion. The motion was placed unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to approve the Administrative Ruling:

- Any child is given the option to move to another school in order to alleviate overcrowding will be provided transportation to the receiving school as long as the student is enrolled there.
- Any child that transfers due to school preference will not be provided transportation.

Mrs. Priester seconded the motion. The motion was adopted unanimously.
