Jasper County School District schools and district offices will resume *full operation* **Monday, September 9, 2019**. Schools will operate on normal schedule as well as our buses.

As we prepare to refocus, reignite, and resume our primary focus; Teaching and Learning...the following information denotes Jasper County School District Make-up Days:

Per state law (S.C. Code Ann. §59-1-425), all districts must set aside three days in the annual calendar to be used as make-up days. Jasper County School District three make-up days, as listed on the approved 2019-2020 calendar, are: December 20, 2019, January 17, 2020, and February 17, 2020.
