- **SLAHD does not provide supervision at the off-campus bus stops. SLAHD does not provide supervision between the bus stop and the campus.**
- Bus riders are to follow behavior and grooming expectations set forth in Cadet Handbook. It is further agreed that if a cadet gets on the bus in improper dress code, a member of the family will bring clothing to school, so the cadet is properly dressed for the school day. _____ **Parent/Guardian Initial**
- Cadets must carry their bus passes on their person at all times. Bus passes must be presented to the bus driver or other SLAHD personnel upon request. Bus privileges may be revoked should this policy be violated. _____ **Parent/Guardian Initial**
- Walking can be hazardous and I assume all responsibility for my child between home and the bus stop. The safety of my student while walking to and from the bus stop is my responsibility and not the responsibility of SLAHD, its agents, employees, volunteers, contractors, or authorizer. _____ **Parent/Guardian Initial**
- Students must follow the rules of bus behavior--which coincide with campus behavior standards--as established by SLAHD and/or bus operator. This extends to bus stops as well. Discipline may include suspending or revoking bus privileges. Bus pass refunds will not be issued under these circumstances. _____ **Parent/Guardian Initial**
- SLAHD does not assume any liability or responsibility for accidents occurring between the time student leaves home (or the campus) and gets on or off of the bus. _____ **Parent/Guardian Initial**
- SLAHD reserves the right to revoke a participant's ability to participate in this bus transportation if rules are not adhered to or the privilege is being abused. _____ **Parent/Guardian Initial**
