**Cost:** SCS Protection Plan costs \$25 per student – Maximum \$75 for families with 3 or more iPads

**Coverage:** SCS Protection Plan allows for two claims for repairs of accidental damage within the coverage dates of July 30, 2018 – May 31, 2019.

**Deductible:** There is a tiered deductible for each claim. The deductible for the first claim is \$20 and the deductible for the second claim is \$50. Parents will have the option to pay the full cost of one minor repair in order to preserve a claim under the SCS Protection Plan. The deductible will be owed to Shelbyville Central Schools.

Loss of device is not covered by the SCS Protection Plan. Replacement cost of a lost iPad and case combined is \$330. In the case of theft or suspected theft, a police report needs to be filed by the parent/guardian as well. If no police report is filed by the parent/guardian for a missing device, then the device will be considered lost.

If you choose to participate in the SCS iPad Protection Plan for 1:1 Student Devices you must submit your payment with this signed form.

If a family chooses not to participate in the SCS iPad Protection Plan for 1:1 Student Devices, the family will be responsible for the full cost of any repair or replacement of the student device.

## Shelbyville Central Schools Details for the SCS Protection Plan for 1:1 Device

Shelbyville Central Schools will offer an optional protection plan for student iPads. Enrollment in the SCS 1:1 Device Protection Plan is optional with the understanding that parents/students carry increased financial liability if no protection plan is selected.

SCS Protection Plan covers “accidental damage” to the device and is designed to limit a family’s financial responsibilities for any damages as described below.

To enroll in the program after 21 days after first day in school, submit the SCS Protection Plan form and payment. The building will be notified and the iPad must first be inspected by the Technology Department. Any repairs to existing damage must be made at full cost and any outstanding payments must be reconciled before coverage will go into effect.

- SCS Protection Plan costs \$25 per student – Maximum \$75 for families with 3 or more iPads
- Should the iPad or accessories issued be stolen, lost or damaged in any way, the issue will be reported to the school and, in the case of theft or suspected theft, a police report needs to be filed by the parents as well.
- Loss of device is not covered by the SCS Protection Plan. Replacement cost of a lost iPad and case combined is \$330.
- If no police report is filed by the parents for a missing device, then the device will be considered lost.
- The coverage is good for 1 school year. Must be renewed at the start of each school year.
- The SCS Device Protection Plan covers accidental damage to iPads assigned to students.
- Damaged determined by administration to be intentional or negligent will not be covered by the Protection Plan. Parents will be charged the full amount for damage or repair.
- “Jailbreaking” or circumventing the security setup on the device results in the loss of the protection provided by the SCS Protection Plan. Parents and students will then be responsible for any and all fees and/or replacement of the iPad.
- Shelbyville Central Schools must complete all repairs or replacement of devices.
- Loss or theft of device is not covered by the SCS Protection Plan. Replacement cost of a lost iPad and case combined is \$330.
- If no police report is filed by the parents for a missing device, then the device will be considered lost.
- Maximum of 2 claims per school year. After the 2nd claim, any subsequent repairs would be at full cost.

Parents will have the option to pay the full cost of one minor repair in order to preserve a claim under the SCS Protection Plan. As an example, if the first issue is replacing a broken camera and the full repair cost is \$20, the parent has the option to pay the \$20 repair cost for the camera in order to preserve both claims in their SCS Protection Plan in case there are bigger issues later in the school year. This option is only available one time in a school year.
