PART I. GENERAL EXPECTATIONS

The Compass Center agrees to implement the following statutory requirements:

1. The Compass Center will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:

Through regularly scheduled parent meetings at flexible times, including Open House and Informational Nights and home visits.

4. The Compass Center will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

Publishing the School-Parent Compact in multiple formats and it will be provided at the library, online, and sent home. There will also be a video on the website for the parents.

5. The Compass Center will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

Telephone, email, parent conference meetings, home visits, text messages, call out system.

6. The Compass Center will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

Mailing the State assessment report to the parents.

7. The Compass Center will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

Notifying the parent through written documentation within the first 4 weeks of school..

8. The Compass Center will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state’s academic content standards,
- the state’s student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child’s progress, and
- how to work with educators:

Flexible Parent Informational Nights, Open House, Informational postings on Compass Center website, home visits.

9. The Compass Center will provide materials and training to help parents work with their children to improve their children’s academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

Hosting informational nights, posting information on the website as well as sending information home through the mail.

10. The Compass Center will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Utilizing School Messenger and Skyward Family Access, and parent-teacher conferences.

11. The Compass Center will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, and Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

The Counseling department, Career and Technology Director and College and Career Advisor will provide career counseling for all students and will create a post-secondary plan for each student with parental input.

12. The Compass Center will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

By sending out messages via School Messenger, posting announcements on the school website, school messenger, and by making sure information is available in both languages.
