## **Miss Union Academy All Around Competition Scholarship**

The Miss Union Academy All Around Competition is presenting academic scholarships to eligible contestants for use in furthering their education. Each senior contestant should review the eligibility requirements and prepare an essay as outlined below.

### **Scholarship Description and Deadline**

To be considered for the scholarship, each contestant should complete the following:

- 1. Compose a 300 to 500 word essay describing the 3 C's of Union Academy (Challenge, Character and Community) and how the scholarship would be used**
- 2. The essay should be:**
  - a. Typed**
  - b. Double spaced**
  - c. Calibri Font (12)**
  - d. Include contestants name in the top left in all caps and bold**

### **Eligibility Requirements**

To be considered to compete for the scholarships, the contestants must meet the following eligibility requirements:

- 1. The contestant must be a non-repeating senior in good standing on September 1, 2016 at Union Academy Charter School.**
- 2. The contestants age shall not be less than sixteen (16) and not more than (22) years on September 1, 2018. Contestants must provide a copy of birth certificate or driver's license as proof of age.**
- 3. The contestant must have a grade point average (GPA) of 2.0 or higher on a 4.0 grade scale at the completion of their junior year. Contestants should provide a copy of their transcript (signed permission by parent on the Miss Union Academy All Around Entry Form), showing their current GPA as proof of their grade point average.**
- 4. The contestant must not be married or pregnant nor have been married, had marriage annulled or have been pregnant.**
- 5. The contestant must not use or consume any illegal, controlled or dangerous substances and/or abuse the use of alcohol or other illegal, controlled or dangerous substances.**
- 6. The contestant must be of good moral character, shall not have been convicted of any crimes and shall possess poise, personality, intelligence, charm and good communication skills.**

7. This scholarship award is given with the intention that the recipient has applied for or has the intention of continuing their education beyond high school at a college, university or technical school in the fall after graduation of their senior high school year. The scholarship award will be directly sent to the institution where participant will be enrolled.
