Event Details and Rules

Event: Two full size busses will be placed side by side. Two teams will participate at the same time. The objective is to pull the bus 20 feet in the shortest amount of time. Both teams will have their pulls timed. Times will then be posted. The team with the overall quickest time will be the winner. Trophies will be awarded to the top three teams. A banner will be awarded to the school team with the quickest time.

1. **When:** The SCPS 2018 Bus Pull event will be held on Saturday, December 15, 2018
2. **Where:** Great Hope Golf Course Parking Lot; Rt. 413; Westover, MD
3. **Time:** The SCPS 2018 Bus Pull event will begin at 11:00 AM
4. **Registration:** Registration forms are available at www.somerset.k12.md.us and should be submitted to the Somerset County Board of Education office to Mr. Tom Davis by close of business on Wednesday, Dec. 12, 2018
On-site registration on Saturday, December 15, 2018 will be available. On-site registration will begin at 10:00 AM.
5. **Teams:** All team members must be 18 years of age or older. (proof of age will be required)
All teams will be Co-Ed. 4-member Teams; 2 male & 2 female.
Entry Fee: A United Way donation of \$40.00 per team will be the entry fee to participate
6. **Release & Waiver of Liability Agreement:** In order to participate in this event, each member from each team will be required to sign the Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement.
7. Two full-size busses will be used.
8. Teams will pull the bus 20 feet and be timed.
9. A rope will be attached to each bus and used to pull the bus.
10. **“Practice Pulls”** : teams will be given an opportunity for a “Practice Pull” prior to the start of the competition. The cost of each “Practice Pull” will be \$25. There will be a limit of one (1) “Practice Pull” per team.
11. **“Second Pull”** : teams wishing to improve their time, will be given one opportunity at the conclusion of the event for a “Second pull”. The cost for this opportunity will be \$25 per team. The team **MUST** be comprised of all original members who participated in their competitive pull.
12. **Trophies:** Trophies will be awarded to each member of the 1st, 2nd and 3rd place teams.
13. **School Banner:** The school with a team who has the quickest time amongst the other school teams will receive a banner to hang in their building.

Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

I desire to participate in the 2018 SCPS Bus Pull on December 15, 2018 (the "Event")

In consideration of participating in the event, I understand and agree to the terms set forth in this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement ("Agreement").

1. I understand that the SCPS Bus Pull is a dangerous activity and involves risk, conditions and hazards that could result in serious personal injury, property damage or even death. I understand that during the course of the Event risks, conditions and hazards could be present, including but not limited to, other participants falling down in my path, collisions with other participants, tripping, the bus striking me, equipment malfunction, rope burns and falling.
2. I understand that the Event has inherent dangers that cannot be eliminated by Somerset County Public Schools.
3. Knowing these risks, conditions and hazards, I want to participate in the Event and voluntarily assume the risks, conditions, and hazards, whether known or unknown, and the dangers of personal injury, property damage and death inherent in the Event. I take full responsibility for my own safety and welfare and the risks, conditions and hazards which may occur whether they are known or unknown.
4. I am physically fit and capable of participating in the Event. I avow that I have no current or pre-existing condition that would be affected by participation in the Event.
5. I agree that I will not sue or make any kind of claim against Somerset County Public Schools, its Board of Education, Superintendent, Somerset County Parks & Recreational Dept., it's staff or volunteers (collectively, the "Releasees") for any liability, whether known or unknown, relating to or arising out of my participation in the Event, including without limitation any personal injury, property damage or death that may result from the negligence, carelessness or recklessness of the Event, participants, observers or any of the Releasees.
6. I agree to indemnify and hold harmless the Releasees from and against any claims, loss, damage or liability to or arising out of my participation in the Event, even if the claims, loss, damage, or liability are the results of acts or omissions of Releasees' employees or agents.

7. I agree that this Agreement shall be governed exclusively by Maryland law (except for its choice of law). If any portion of this Agreement is found to be unenforceable, the remainder of the Agreement will remain in full force and effect.

8. I certify that I am at least 18 years of age and competent to enter into this Agreement

9. This Agreement is binding upon my heirs and assigns.

I HAVE READ AND UNDERSTAND THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT AND HAVE EXECUTED IT VOLUNTARILY. I UNDERSTAND THAT BY SIGNING THIS AGREEMENT I AM GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN THE EVENT OF ANY PERSONAL INJURY, PROPERTY DAMAGE OR DEATH.
