Dear Parent/Guardian:

Whooping cough, also known as pertussis, continues to threaten students in California. To help stop its spread, all incoming 7th graders are required by law to have proof of a whooping cough booster ('Tdap') shot, in order to attend 2019-2020 school year. Students will not be allowed to attend classes without a shot record. Under California law, all incoming 7th graders need to be immunized with Tdap and have 2 MMR doses for the new school year. If your son/daughter hasn't had a booster shot yet, please schedule an appointment immediately with your regular doctor. If your son or daughter has already received the booster shot, please submit a copy of the shot record by: May 1, 2019.

La tos ferina sigue amenazando escuelas en California. Para ayudar a poner fin a su propagación, todos los estudiantes ingresando al 7º grado están obligados por ley a presentar un comprobante de la vacuna de refuerzo contra la tos ferina ("Tdap"), para asistir a clases el año escolar 2019-2020. Los estudiantes no podrán asistir a la escuela sin un comprobante de vacunación. Bajo la ley de California, todos los alumnos que ingresan al 7mo grado deben ser inmunizados con la vacuna Tdap y tener 2 dosis de MMR para el nuevo año escolar. Para mas informacion sobre vacunas requeridas para la escuela, visite www.shotsforschool.org.

Si su hijo(a) no se ha puesto el refuerzo de la vacuna, por favor haga una cita inmediatamente con su doctor. Si su hijo(a) ya recibió la vacuna de refuerzo, por favor denos una copia del comprobante de vacunación antes de: Mayo 1, 2019.
