The **National Honor Society (NHS)** is a national organization serving secondary schools for the purpose of creating enthusiasm for scholarship, stimulating a desire to render service, promoting strength in leadership, and developing character in students. The organization is administered by officers at the state and national levels. The NHS website is <http://www.nhs.us> The Burlington School has been awarded a local chapter which became effective on October 12, 2011. TBS has appointed Dr. Fasan as the Chapter Advisor.

Chapter membership decisions will be based upon the candidate's proof of scholarship, service, leadership and character. They will also be based on how well the candidates embody the mission of The Burlington School. These characteristics are defined as follows.

Scholarship: In order to be eligible to apply to NHS, a student must have a cumulative GPA of 90 in each of the five core classes (English, Math, Science, History, Foreign Language) over the course of their entire high school career, through their most recently completed trimester prior to application. All other courses must be passed with an 85 or above each trimester. Courses graded on a pass/fail basis (such as E-mersion and SAT Prep) must be passed.

Service: In order to be selected for NHS, a student must show a commitment to and passion for serving others and making the community around them a better place. This should be demonstrated through community service that goes above and beyond the hours required by TBS, and should include service both to the school as well as to the greater community outside school.

Leadership: In order to be selected for NHS, a student must demonstrate a commitment to and a passion for leadership. This should include both formal leadership roles as well as informal roles such as being a role model in the classroom. An ideal candidate for NHS is active in multiple organizations, both in and outside of TBS.

Character: In order to be selected for NHS, a student must demonstrate the following six qualities of character: trustworthiness, respect, responsibility, fairness, caring and citizenship. Additionally, candidates must generally maintain a clean disciplinary record and should show maturity and growth from any issues or setbacks they encounter.

Application Procedure

A candidate must be a sophomore or junior as determined by TBS and have completed at least two trimesters at TBS. Candidates will appear before at least two members of the NHS Faculty Council for interviews. The Faculty Council will recommend its decisions to Mr. Ronnie, Wall, Head of School, who will give final approval of all applicants.

Students should use the form below to request a copy of their current transcript and attach the transcript to the application. The transcript along with the attached candidate form should be completed and returned to Dr. Fasan by 4:00 on _____. Please also include the signature of a parent or guardian below.

Appeals Process

If a candidate is not admitted to NHS, the student must appeal by letter stating the reasons for the appeal. Appeals must be addressed to the faculty advisor and are due by 4:00 pm on _____ or they will not be considered. The Faculty Council will make its recommendation to the Head of School who will have final say in all appeals.
