

PARENTAL INVOLVEMENT POLICY FOR PLEASANT VIEW ELEMENTARY SCHOOL

Pleasant View Elementary School, in consultation with teachers, principals, program administrators, and parents of participating children, has developed and agreed upon this parental involvement policy. In keeping with the policy, the following events and activities are available to enhance parent involvement:

- Spring Title 1 Parent Meeting
- Summer Reading Activity Bag
- 800 Minute Summer Reading Challenge
- Event at May Fair

Pleasant View Elementary School welcomes the participation of parents in support of student learning, and recognizes that parental involvement increases the opportunities for student success. It is the policy of **Pleasant View Elementary School** to foster and maintain ongoing communications with parents concerning their opportunities for involvement, their children’s eligibility for special programs, their children’s educational progress, the professional qualifications of their children’s teachers, and the status of their children’s schools.

The Title 1 Parental Involvement section of the *No Child Left Behind Act (NCLB)* requires each Title 1 school to develop a written parental involvement policy that describes the means for carrying out the requirements of Section 1118. The school must ensure that information related to school and parent programs, meetings and other activities are sent to the parents of Title 1 children in a format and in a language the parents can understand.

3. Parent meetings, including parent conferences, will be held at different times during the day.
4. Title 1 and/or district funds may be used to pay reasonable and necessary expenses associated with parental involvement activities. Parent Involvement activities at Pleasant View include: Title 1 Parent Meetings (evening and day times available), parent volunteers involved in Kid-Writing, reading, clerical, PTO activities, Parent Loan Library, Family Visitation Day, Book Fairs, grade-level curriculum events, Study Island home component in reading and math, Book Bingo Night, PTO family events, PTO-purchased book for each student annually, and a partnership with Kaltreider-Benfer Library to promote literacy, using Book Flix.
5. Parents will be involved in the planning, review, and improvement of the school’s Title 1/Remedial Reading program.
6. The school will involve parents in the joint development of the School Improvement Plan, under Section 1116. (Applies only to Title 1 schools identified for School Improvement.)
7. The school will provide parents of participating children with timely information regarding the Title 1/Remedial Reading program.
8. The school will provide parents of participating children with a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and expected student proficiency levels.
9. The school will provide assistance to parents in understanding the State’s academic content standards and student achievement standards, local academic assessments, and methods to monitor a child’s progress as well as work with teachers to improve the academic achievement of their children.
10. The school will provide to parents, upon request, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions related to the education of their children. The school will respond to any suggestions as soon as practicably possible.
11. The school will provide to parents, upon request, a copy of the *School-Home Compact*, which outlines the ways in which parents, school staff, and students will share in the responsibility of improving student academic achievement.
