School Facility Conditions and Planned Improvements (Most Recent Year)

Compton School was built in 1960 and modernized in 2014. It sits on 9.9 acres of which 4.01 acres is playground. This school has 27 classrooms, a multi-purpose facility, science lab, music room, computer lab, wood shop, instructional materials center and a library. The campus has staff dining and a workroom.

District Funds were used to provide and install 3 new relocatable classrooms for growth and 1 portable restroom.

The custodial staff adheres to a weekly cleaning schedule that includes classrooms, restrooms, cafeteria and kitchen areas.

The District’s Mobile Maintenance Team visits the school site at least twice a year. Maintenance emergencies are addressed immediately. District personnel maintain the grounds at least once every two weeks.

This site also is maintained to ensure a clean, safe, and functional facility as determined pursuant to a Facility Inspection Tool developed by the State of California Office of Public School Construction.

In addition to monthly Parent Booster Club meetings, parents may be involved in the following ways:

- School Site Council – Elected parents form 25% of the council and oversee the implementation of the school plan.
- English Learner Advisory Committee – Parents are nominated and sit on the committee in an advisory capacity for School Site Council.
- Student Intervention Team Meetings – Parents are formally invited to attend and participate in meetings that focus on intervention strategies for their child
- English Learner Reclassification Meetings – Parents of English Learners are formally invited to attend Language Acquisition Team meeting to determine the language status reclassification of their child. They are also invited to attend a celebration of their child’s reclassification.
- Awards Assemblies – Parents are formally invited to attend and watch their child receive an award.
- Back to school night – Parents are invited to school to visit their child's classes and meet their teachers. They will also gain an insight to what goes on in their classes on a daily basis.
- Title I Parent Meeting – All parents are invited each year to attend a meeting focusing on categorical funds and how they are used to improve student achievement at Compton.
- Parent Conference Weeks – Two weeks each year are set aside for parents to attend meetings after school in regard to their individual child and his/her academics.
- Spring and Winter concerts – Twice a year our parents are invited to watch and listen to a performance put on by our music department.
- Assisting coaching on the various academic and athletic teams.

- Student incentive activities - Parents help develop and coordinate student academic, behavioral, and attendance activities: dances, picnics, rallies, talent shows, and carnivals.
- Family Picnics and Parent Cafes are held monthly in order to connect with families and provide a forum for parent input.
- Quarterly Parent Education Nights will address current needs with regard to parenting and support student learning.
- A Parent Center is now open to provide resources and education to our parents.
- A yearly survey is distributed in order to garner parent input.

In addition, a newsletter is mailed home monthly, translated into Spanish. The newsletter includes a letter from the Principal, Vice Principal, Academic Program Leader and FACE.. There is also a monthly calendar, articles from various support staff, recognition of students, Booster Club news, and school website. Annual events include Back to School Night, Title I meetings, fundraisers, concerts, awards assemblies, 7th grade orientation, and eighth grade graduation. Compton's School Safety Plan is current and is updated annually. Key elements of Compton's School Safety Plan include the following: (a) routine and emergency disaster procedures; (b) suspension, and expulsion procedures; (c) teacher notification of pupils with a specific discipline history; (d) child abuse reporting procedures, (e) the district's sexual harassment policy; (f) school crime data; (g) the student dress code; (h) safe entrance and exit procedures; (i) the civil defense and disaster plan; and (j) discipline rules and procedures. Our overall goal is to maintain a safe and orderly school environment conducive to learning.

Professional Development (Most Recent Three Years)

Professional development is designed to provide continuous learning opportunities for administrators, teachers, and classified personnel. Training opportunities affirm the basic philosophy of education that learning is a lifelong process that contributes to the well-being of the students, teachers, administrators, and community. Professional Development is an essential component of effective instruction and student learning.

All training revolves around identified needs of students and adults for the purpose of the improvement of instruction and increasing content knowledge. Central to all training are student achievement data, district focus areas, the Common Core State Standards, the state adopted standards-based instructional materials, and strategies to effectively teach the academic content standards to all students.

The district created professional development based on the Common Core State Standards for teachers and administrators. The modules included a Common Core overview, Mathematical Practices, Cross-Curricular/Evidence Based Writing, Text Complexity/Academic Vocabulary, including ELD standards for California. We also provided extensive professional development for Professional Learning Communities through our Service Delivery Model. On-site coaching and support is provided by academic coaches for reading/language arts, mathematics, science and writing. The district provides time and resources for collaboration, planning, and professional development. Additionally, we provided professional development on Multi-Tiered Systems of Support and Support to school and district teams.

Teachers new to the District received four days of professional development prior to the beginning of the school year focused on orientation to District and school site policies and services, Common Core State Standards, classroom management, curriculum and pacing, and setting up the classroom. Teachers in their second year with the District received two days of professional development prior to the beginning of the school year focused on best practices for improving student achievement.

New teachers with California preliminary credentials received professional development through the Beginning Teacher Support and Assessment (BTSA) program. The focus of training was in the Formative Assessment for California Teachers (FACT), California Standards for the Teaching Profession (CSTP), meeting the California Induction standards, and the California Academic Content Standards. Each beginning teacher was assigned a veteran teacher who served as a mentor. The mentors received on-going professional development in FACT, coaching strategies, and instructional techniques. Professional development was provided through individual mentoring, monthly meetings, and after-school workshops.

Intern teachers received professional development at monthly meetings focusing on the initial teaching skills of the CSTP including classroom management, lesson planning, assessment, and establishing a climate that is conducive to student achievement. Each Intern was assigned a mentor that provided day-to-day support in these areas as well as advisement toward meeting credential requirements. Mentors received monthly professional development in meeting the needs of Intern teachers. Interns also received coursework and supervision from universities partnered with BCSD to provide the Intern Program.
