19-015	Motion by Loyd, supported by Sheppard, that based upon consideration of the seven factors identified in Section 1311(6)(e) of the Revised School Code, the Petition for Reinstatement on behalf of Student 2018-19 R1 is conditionally granted as placement at Allen Park Community School, with the following conditions: a) Reassurance that guns are not accessible to student b) Risk assessment prior to return to school c) Regular meetings with school social worker d) Board strongly recommends outside counseling at the parents' expense e) Review by Board of Education to return to APHS for senior year, if desired, providing that all required course work and credits have been fulfilled, and further, provided the family agrees to counseling or social work support outside of school at the family's expense and the ability for the district to communicate with said agency or doctor.
