Dear Mr. Hinz:

Under Education Code (EC) Section 42131, the Los Angeles County Superintendent of Schools (County Superintendent) has completed a review of the Lowell Joint School District's (District) 2017-18 Second Interim Report. Our analysis of the data provided indicates that the District should be able to meet its financial obligations for the current and two subsequent years. **We therefore concur with the District's positive certification** and offer our comments.

DEFICIT SPENDING

The District is projecting an operating deficit of approximately \$500,000 for 2017-18. This level of deficit spending represents 2.0 percent of the unrestricted General Fund's budgeted outgo. The District is also projecting operating deficits of approximately \$157,000 and \$691,000 for 2018-19 and 2019-20, representing less than one percent and 2.6 percent, respectively. According to our review, and as confirmed by the District, the projected deficits are primarily due rising health benefit costs and increasing PERS/STRS contributions. While the District projects to maintain the required level of reserves in all three years, the causes of deficit spending should be recognized and monitored so they remain manageable.

LABOR CONTRACT NEGOTIATIONS

According to the information provided in the District's Second Interim Report, certificated labor contract negotiations for 2017-18 and classified for 2016-17, 2017-18 remain unsettled and potential changes have not been calculated and incorporated into projected salary and benefit expenditures.
