

**WAIVER AND RELEASE BY PARENT OF MINOR CHILD**

We, on behalf of \_\_\_\_\_ (hereinafter referred to as "Child"), hereby waive and release, indemnify, hold harmless, and forever discharge St. Joseph Catholic School, St. Anthony Catholic School, the Catholic Diocese of Jackson, its agents, employees, officers, directors, affiliates, successors, managers, members, and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages, and liabilities, of every kind and nature, whether known or unknown, in law or equity, that we or Child ever had or may have, arising from or in any way related to Child's unsupervised walking to/from St. Anthony/Joseph Catholic Schools.

We understand that said Child will be walking unaccompanied by an adult and that no monitoring will be provided by either St. Joseph School or St. Anthony School. We understand there may be inherent danger due to motor vehicle movement as well as athletic practices and play that could cause serious or grievous injuries, including bodily injury, damage to personal property, and/or death.

On behalf of ourselves, Child, heirs, assigns, and next of kin, we and said Child waive all claims for damages, injuries, and death sustained to me or my property, that we or said Child may have against the aforementioned released party to such activity. Child has the necessary and requisite skills to walk unaccompanied between St. Joseph and St. Anthony Schools.

By this Waiver, we, on behalf of said Child, assume any risk, and take full responsibility and waive and relinquish any and all claims of any sort, whether in tort, contract, equity, or otherwise, including any claims of personal injury, death, or damage to personal property

This Waiver and Release contains the entire agreement between the parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this Waiver and Release. The provisions of this Waiver and Release may be waived, altered, amended, or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of this Waiver and Release will continue in full force and effect even after the termination of the activity whether by agreement, by operation of law, or otherwise. We have read, understand, and fully agree to the terms of this Waiver and Release. We understand and confirm that by signing this Waiver and Release said Child and we have given up considerable future legal rights.

We have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise, or guarantee being communicated to me. Our signatures are proof of our intention to execute a complete and unconditional Waiver and Release of all liability to the fullest extent of the law.
