- If driving siblings (Family Members only) According to the California DMV, you must carry a signed statement by a parent/ legal guardian, stating the reason and the probable end date of the necessity to drive the immediate family member.

### Rules and Regulations for students parking permit

San Jacinto Valley Academy or the State of California will not be responsible for any damage or loss of property while your car is parked on school grounds. This includes break-ins, vandalism, hit and run, theft etc. You may involve the police on any of the above offences.

#### Please read the following and Initial

\_\_\_ Student must show current registration, proof of insurance, and a valid driver's license to obtain parking privileges and student must carry proof of insurance with the vehicle at all times.

\_\_\_ Parking regulations are strictly enforced. Suspension of parking privileges from school may occur when violations of the regulations occur. These include speeding, illegal parking, not following the traffic pattern or signs in the parking and all other infractions of civil or criminal laws.

\_\_\_ Students are to park in the student parking located at the north end parking and should be parked in a parking space.

\_\_\_ Students are not permitted to park in the front office parking lot. The student will have their parking privileges revoked.

\_\_\_ Students are not permitted to drive in another student's car, without prior permission from parents. Written permission must be submitted to the office.

\_\_\_ The speed limit is 5 miles per hour.

\_\_\_ Vehicles are not to be removed from the parking lot during the day without authorization of administration.

\_\_\_ When leaving campus students must always stop with the supervisor before exiting and sign in or sign out (No exceptions)

\_\_\_ Drivers and passengers **must always** have their School ID card and off campus pass to leave campus during lunch or early dismissal. Students are not to leave items in their car to get later.

\_\_\_ Seniors using their car to go off campus at lunch are responsible for returning to class on time. Any senior chronically tardy to class may lose senior lunch privileges.

\_\_\_ Parking passes must be returned at the end of the school year.

\_\_\_ Students allowing someone else to use their parking pass will have their parking pass revoked.

\_\_\_ If improperly parked (doubled parked, blocking entry ways or illegally parked), or if the proper student parking permit is not clearly visible, car may be towed away at owner's expense.

\_\_\_ The School is NOT responsible for the vehicle or its contents. Students are advised to leave vehicle(s) locked at all times.

\_\_\_ Once parked student is not permitted to stay in the car, or return to the parking lot during school hours which includes lunch time and between classes without authorization from Administration.

\_\_\_ Parking permits must always be in full view, hanging and displayed on the rear-view mirror of the registered Vehicle.
