

Notice for Commercial Plan Members who are or will be eligible for Medicare in 2018 and 2019. This does not apply to plans that do not have prescription drug coverage through Health New England.

Important Notice from Health New England about Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with Health New England and about your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage in your area. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:

1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
2. Health New England has determined that the prescription drug coverage offered by your Plan is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.

When can you join a Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15 to December 7.

However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

What happens to your current coverage if you decide to join a Medicare Drug Plan?

If you are enrolled in one of the Health New England Medicare Advantage Plans and you choose to join a Medicare drug plan, your current Health New England Medicare Advantage coverage will be affected. CMS regulations state that a Medicare Beneficiary enrolled in a Medicare Advantage Plan may not enroll in a different Prescription Drug Plan (a plan that covers prescriptions only). Your current coverage pays for other health expenses in addition to prescription drugs. If you enroll in a new Medicare prescription drug plan, you and your eligible dependents still will not be eligible to receive all of your current health and prescription drug benefits through a Health New England Medicare Advantage Plan.

If you do decide to join a Medicare drug plan and drop your current Health New England coverage, be aware that you and your dependents will not be able to get this coverage back until the next Medicare open enrollment period.

If you are enrolled in any of Health New England's other products, you may enroll in Medicare Part D if you so choose. This decision will not affect your Health New England coverage. Your prescription drug coverage and your medical coverage through Health New England are tied together. If you have prescription drugs coverage through Health New England, you cannot cancel it without cancelling all of your medical coverage. If you cancel your Health New England Coverage, you should be sure that your medical coverage needs will be met.

If you do decide to join a Medicare drug plan and drop your current Health New England coverage, be aware that you and your dependents may not be able to get this coverage back.

When will you pay a higher premium (penalty) to join a Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with Health New England and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later.

If you go 63 continuous days or longer without creditable prescription drug coverage, your monthly premium may go up by at least 1% of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (a penalty) as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following October to join.

Remember: Keep this Creditable Coverage notice. If you decide to join one of the Medicare drug plans, you may be required to provide a copy of this notice when you join to show whether or not you have maintained creditable coverage and, therefore, whether or not you are required to pay a higher premium (a penalty).
