1. All students in K-8 must wear their St. Elizabeth Gym Uniforms.
2. Only grades 1, 2, 3 and 4 will be participating at the Wyckoff Y. Grades 5-8 will remain at school.
3. Grade 4 will be swimming at the Y. Girls must tie their hair back in a ponytail and must rinse off in the locker room showers before entering the pool. All students are to wear their bathing suits under gym clothes to school. Pack a towel and underwear. The students will change back into their gym uniforms after swimming. Girls must wear one piece bathing suits or "tankinis". No bikini please.
4. The Y will provide a snack for grades 1, 2, 3 and 4.
5. Remember to dress your children appropriately for the weather.
