| <p>Athletic Eligibility - Academics: Must have passed a minimum academic load during the previous semester, and meet local promotion standards. Students in the "traditional schedule" must pass at least five courses (two of which need to be math and language arts) and meet local promotion standards. Rising 7th graders enter the 1st semester with academic exemption.</p> | | | | | | | | | | | | | |
| <p>Athletic Eligibility - Attendance: Must be a properly enrolled student at the time you participate, must be enrolled no later than the 15th day of the present semester; and must be in regular attendance at that school.</p> <ul style="list-style-type: none"> ▪ Must have been in attendance for at least 90% of the previous semester at an approved school. Student must not miss more than 9 (nine) days during a semester. ▪ Must not have exceeded four consecutive semesters of attendance or have participated more than two seasons in any sport since first entering grade 7. Rising 7th graders enter the 1st semester with attendance exemption. | | | | | | | | | | | | | |
| <p>Athletic Eligibility - Change of Residence or Special Transfer: Must live with your parents or legal custodian within the school administrative unit (exceptions must be approved by your principal and the NCHSAA). A student is eligible if he has attended school within that unit the previous two semesters (if eligible in all other respects).</p> <ul style="list-style-type: none"> ▪ Must not falsify any official eligibility information such as residency/address. Penalty for such acts will result in loss of eligibility for 365 days. ▪ A release from domicile school system must be on file with Yadkin County Schools prior to a student practicing or playing in a sport. <p><input type="checkbox"/> Place checkmark in brackets verifying that address listed above is correct</p> | | | | | | | | | | | | | |
| <p>Certification and Medical Authorization: We certify that all of the information provided by us on this form is correct.
