



# North County Trade Tech High School Participation Agreement for 2018-2019

At North County Trade Tech High School (NCTT), parents, students and staff work together to ensure the best education for your child. In order to confirm you child’s acceptance into this program, we would like you to look at the following requirements and sign, **notifying us that you are willing to accept and help enforce these responsibilities.**

1. Be on time to school and maintain good attendance and academic standing.
2. Act responsibly and maintain good conduct in school and on fieldtrips.
3. Come prepared each day and bring a positive attitude.
4. Be dressed appropriately according to the dress code, including only closed toed shoes.
5. Complete the required schoolwide project each semester.
6. Be willing to explore and work in all courses independently and collaboratively.
7. Keep cell phones and electronic devices turned off and in your backpack or purse during the school day, except at lunch and with permission of the teacher.
8. **Have all communication with parents through the office. (Parents will communicate with student through the office as well.)**

**Academic / Behavior / Attendance Probationary Status, or Dismissal (Request to Exit):**

If serious or habitual problems arise, we will work with you to seek a solution that allows your child to continue in our learning community. If the problem persists, your child will be placed on “probation” which means that the administration will reserve the right to deny your child enrollment at NCTT the following year.

(Note: California Law permits the charter school to hold the parents liable for damages up to \$17,593 of any equipment, materials, and/or school property (Civil code 1714.1). )

By signing below, I agree that my child will attend NCTT during the 2018-19 school year. I agree to adhere to the expectations set forth on the North County Trade Tech High School Participation Agreement and in the Student Handbook. I will work with my child to make sure that he/she understands what is expected of him/her and will fulfill my part to ensure that our learning community is a productive and positive environment as set forth in the Student Handbook and the “General Standards, Policies and Uniform Complaint Process” document.
