The Bibb County Board of Education met in a Called Session on May 22, 2018, at 6:00 pm at West Blocton High School, lunchroom. The Invocation was given by Mrs. Dailey followed by the Pledge of Allegiance led by Mr. McMillan. Roll Call was conducted by Board President, Mr. Mike Oakley:

Mr. Moody made a motion to approve the agenda. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Dailey made a motion to approve a stipend for up to 3 teachers to attend ready to work training at Shelton State Community College. Training will be 3 days per week for 3 weeks, with a stipend of \$100 per day plus travel expenses, from District General, Title I or Title II funds. Mr. McMillan seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve payment of \$100 per day, for a total of 4 days, to Renee Holifield and Monica Watkins for BES yearbook work. Payment will be made from Brent Elementary School yearbook funds. Mr. McMillan seconded the motion which passed unanimously.
