Purchase Line School District is providing free meals to students through the National School Lunch Program's Seamless Summer Option. These meals are available for any child age 18 and younger.

Beginning Monday, March 23<sup>rd</sup>, the following locations and times will be used while school is not in session. Meals will be delivered on Mondays (2 days of meals) and Wednesdays (3 days of meals). All meals are curbside pickup only. Meals will not be consumed at each location and no one will be permitted inside the buildings. Every child receiving a meal must be present at the time of pick up.
