Lookeba-Sickles Board of Education August 19, 2019, 7:00 p.m. Board Room

The Lookeba-Sickles Board of Education met in a regular board meeting to conduct business for the month of August.

The meeting was called to order at 7:00 p.m. by Mr. House. Members present were Tommy House, Jami Radacy, Frank Klassen, Justin Harvey, and Traci House. Also in attendance were Shirley Gathers, Mike Davis, Shana Lierle, and Savannah Melton. At this time Mr. Davis gave the invocation.

Mrs. Radacy made a motion to approve the Consent Agenda, which included 2019-2020 General Fund Encumbrances #48 thru #69 and #50008 thru #50041. 2019-2020 General Fund Warrants #47 thru #146. 2019-2020 Building Fund Warrants #3 thru #8. 2019-2020 Child Nutrition Fund Encumbrances #11 thru #13. 2019-2020 Child Nutrition Fund Warrants #1 thru #4, that were reviewed and discussed. Mr. Harvey seconded this motion. Voting yes, Ms. Radacy, Mr. Harvey, Mr. House, Mrs. House, and Mr. Klassen. Motion Passed
